AN ORDINANCE OF THE CITY OF KIRKLAND, RELATING TO DRAINAGE BASINS AND SENSITIVE AREAS (WETLANDS, STREAMS, MINOR LAKES, AND FREQUENTLY FLOODED AREAS) AND TO LAND SURFACE MODIFICATION (CLEARING AND GRADING); EXTENDING TO FEBRUARY 15, 2002 INTERIM REGULATIONS FOR SENSITIVE AREAS AND LAND SURFACE MODIFICATION AS ADOPTED BY ORDINANCE NO. 3781; AND AMENDING SECTION 6 OF ORDINANCE NO. 3781.

WHEREAS, the City Council has the authority to adopt interim regulations pursuant to RCW 35A.63.220 and 36.70A.390; and

WHEREAS, by Ordinance 3781, passed on February 20, 2001, the City Council adopted interim regulations that protect the particular functions and values of each drainage basin (sensitive areas); and

WHEREAS, on August 7, 2001, the City Council held a public hearing on renewal of Ordinance No. 3781 until February 15, 2002; and

WHEREAS, the City Council desires to renew Ordinance No. 3781 until February 15, 2002;

NOW, THEREFORE, the City Council of the City of Kirkland do ordain as follows:

<u>Section 1.</u> The City Council finds that renewal or extension of Ordinance No. 3781 is necessary for the reasons stated in the City staff memorandum included in the City Council agenda packet for the August 7, 2001 City Council meeting.

Section 2. Section 6 of Ordinance No. 3781 is amended as follows:

This ordinance shall be effective until February 15, 2002, and may be renewed for one or more six-month periods if a subsequent public hearing is held and findings of fact are made prior to each renewal.

<u>Section 3.</u> This ordinance shall be in effect five days from and after its passage by the Kirkland City Council and publication, pursuant to Section 1.088.017 Kirkland Municipal Code, in the summary form attached to the original of this ordinance, and by this reference approved by the City Council, as required by law.

<u>Section 4.</u> Should any section, paragraph, sentence, clause, phrase or word of this ordinance or the Chapter 90 adopted by reference be

declared invalid or unconstitutional by a court or agency of competent jurisdiction, such invalidity or unconstitutionality shall not affect any of the remaining sections, paragraphs, sentences, clauses, phrases, or words of this ordinance or such Chapter 90, all of which will remain in full force and effect.

<u>Section 1</u>. Provides findings of fact for the ordinance.

<u>Section 2</u>. Extends the interim regulations for six months.

<u>Section 3</u>. Authorizes publication of the ordinance by summary, which summary is approved by the City Council pursuant to Section 1.088.017 Kirkland Municipal Code and establishes the effective date as five days after publication of summary.
