AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO PARK RULES AND AMENDING CHAPTER 11.80.

The City Council of the City of Kirkland do ordain as follows:

<u>Section 1</u>. Section 11.80.060 of the Kirkland Municipal Code is hereby amended to read as follows:

## 11.80.060 Animals at large prohibited.

Dogs must be on a leash that is held by the owner or possessor of the dog at all times. It is unlawful for any person to allow or permit any animal owned by him or within his possession or under his control, to run at large in any park or enter any lake, pond, pool, fountain or stream designated swimming area located therein.

Section 2. Section 11.80.090 of the Kirkland Municipal Code is hereby amended to read as follows:

## 11.80.090 Certain vocations and loudspeakers prohibited.

It is unlawful to <u>sell</u>, <u>solicit</u> or <u>peddle</u> in any <u>park</u>. <u>take up collections</u>, or to-act-as or ply the vocation of a <u>solicitor</u>, agent, <u>peddler</u>, fakir, mendicant, <u>beggar</u>, <u>strolling musician</u>, <u>organ grinder</u>, <u>exhorter</u>, <u>barker</u>, <u>showman</u>, or <u>bootblacks</u>; or without first obtaining a written permit from the director. <u>thereto it is also unlawful</u> to operate or use any <u>metal detectors or loudspeaker or sound amplification devices</u> in any park <u>without first obtaining a written permit from the director</u>.

<u>Section 3</u>. Section 11. 80.100 of the Kirkland Municipal Code is hereby amended to read as follows:

## 11.80.100 Selling refreshments or merchandise or distributing literature.

It is unlawful to sell refreshments or merchandise in any park without first entering into a concession contract according to the rules and regulations of the park and recreation department therefor with the city. It is further-unlawful for any person to distribute-literature of any kind in any park within the city without-first-obtaining a written permit to do so from-the-director. The director shall establish pursuant to Chapter-3.68 and Section-11-80-220, rules and regulations relating to the issuance of such permit which may prohibit the distribution-of literature of a purely "commercial advertising nature" and shall require the deposit with the city-of-a "litter" cleanup deposit in an-amount to be determined by the director-prior to the issuance of any such written permit.

Section 4. Section 11.80.240 of the Kirkland Municipal Code is hereby repealed:

Section 5. This Ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication, as required by law.
