AN ORDINANCE OF THE CITY OF KIRKLAND FINDING THE EXISTENCE OF FUNDS IN EXCESS OF ANTICIPATED REVENUES DURING THE BUDGETARY PERIOD COMMENCING JANUARY 1, 2004, AND AUTHORIZING THE EXPENDITURE OF SAME.





PUBLICATION SUMMARY
OF ORDINANCE NO. 3947

AN ORDINANCE OF THE CITY OF KIRKLAND FINDING THE EXISTENCE OF FUNDS IN EXCESS OF ANTICIPATED REVENUES DURING THE BUDGETARY PERIOD COMMENCING JANUARY 1, 2004, AND AUTHORIZING THE EXPENDITURE OF SAME.

SECTION 1. Provides a report of funds received in excess of anticipated revenues during the budgetary period beginning January 1, 2004, and authorizes the expenditure of same.

SECTION 2. Authorizes publication of the ordinance by summary, which summary is approved by the City Council pursuant to Section 1.08.017 Kirkland Municipal Code and establishes the effective date as five days after publication of summary.

The full text of this Ordinance will be mailed without charge to any person upon request made to the City Clerk for the City of Kirkland. The Ordinance was passed by the Kirkland City Council at its meeting on the 15th day of June, 2004.
