ORDINANCE 0-4898

AN ORDINANCE OF THE CITY OF KIRKLAND EXTENDING THE TERM OF THE PLANNED ACTION ORDINANCE FOR PARKPLACE, APPROVED IN ORDINANCE NO. O-4473 AND AS AMENDED BY ORDINANCE NO. O-4897, AND EXTENDING THE TERM OF THE DEVELOPMENT AGREEMENT FOR PARKPLACE, APPROVED BY RESOLUTION R-5140.

WHEREAS, in February 2015, the City Council adopted a Planned Action Ordinance (Ordinance O-4473) for the Parkplace Project that identified the physical parameters, programming, and design of the development project, a project that is currently known as Kirkland Urban; and

WHEREAS, the purpose of the Planned Action Ordinance was to evaluate the environmental impacts of the Kirkland Urban Project on an area-wide basis early in the planning stage, such that the environmental review of individual development projects within the area could be streamlined; and

WHEREAS, the Planned Action Ordinance was effective for ten years and was set to sunset on March 1, 2025, unless further extended following a public hearing; and

WHEREAS, in August 2015, following adoption of the Planned Action Ordinance, the City Council, through Resolution R-5140, adopted a Development Agreement with KPP Development LLC for the Kirkland Urban Project, which among other things specified the development regulations to which the project would be subject; and

WHEREAS, the term of the Development Agreement was linked to the term of the Planned Action Ordinance, such that it was also set to expire on March 1, 2025, unless the Planned Action Ordinance was extended; and

WHEREAS, much of the Kirkland Urban Project has been developed in the past ten years, but the last phase of the project (Kirkland Urban East) has not yet been completed; and

WHEREAS, on February 18, 2025, the City Council passed Ordinance O-4897 in order to temporarily extended the expiration date of the Planned Action Ordinance to June 1, 2025, in order to allow sufficient time to hold a public hearing prior to any longer-term extension; and

WHEREAS, on April 15, 2025, the City Council held a public hearing regarding the proposed extension of the Planned Action Ordinance and the Development Agreement for the Kirkland Urban Project; and

WHEREAS, the City Council has determined that it is in the City's best interest to extend the Planned Action Ordinance and Development Agreement an additional five years to allow the last phase of the project to be completed; and

WHEREAS, in order to provide this extension, the Sunset provision of the Planned Action Ordinance is hereby amended and the Vesting and Term provisions of the Development Agreement are hereby amended; and

WHEREAS, the Development Agreement binds the successors and assigns of the original property owner but, for clarity, legal successors and assigns are also hereby explicitly referenced in the revised Term section of the Development Agreement; and

WHEREAS, in the event that the developer desires additional time beyond five years, the Planned Action Ordinance and the Development Agreement contemplate extensions for additional terms if again authorized by the City Council after another public hearing.

NOW, THEREFORE, the City Council of the City of Kirkland do ordain as follows:

Section 1. In order to extend the Planned Action Ordinance, for Parkplace, now known as Kirkland Urban, by five years, Section 6 of the Planned Action Ordinance, as adopted in Ordinance O-4473 and as thereafter amended by Ordinance O-4473, is hereby amended to read as follows, with new text shown in <u>underline</u> and deleted text shown in <u>strikethrough</u>; the remainder of Ordinance O-4733 is not modified:

<u>Section 6</u>. <u>Sunset</u>. The provisions of this Ordinance shall be of no force and effect on and after June 1, 2025 2030, unless the Ordinance is extended by the City Council following a report from the SEPA Responsible Official and a public hearing.

<u>Section 2</u>. In order to extend vesting for the Kirkland Urban project by five years, Section 3.1 of the Development Agreement, initially adopted by Resolution R-5140, is hereby amended to read as follows:

3.1 Vesting of Development Regulations.

The provisions of the Kirkland Municipal Code in effect on the day of this Agreement, except as otherwise provided in this Agreement, shall apply to the development of the Kirkland Parkplace Project until the sunset of Ordinance O-4473, the Planned Action Ordinance for the Kirkland Parkplace, or ten years from date of this Agreement, whichever comes first later.

<u>Section 3</u>. In order to extend the Development Agreement by five years, Section 6.10 of the Development Agreement, initially adopted by Resolution R-5140, is hereby amended to read as follows:

- 6. 10 <u>Term.</u> The term of this Agreement shall be ten (10) years through June 1, 2030. The City and KPP (and their legal successors and/or assigns) may agree to extend the term of this Agreement, provided such extension is approved by the City Council.
- <u>Section 4</u>. The City Manager is directed to ensure the property owner and/or developer records a copy of this Ordinance on the property to accurately reflect the extension of the Development Agreement.
- <u>Section 5</u>. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance or the application of the provision to other persons or circumstances is not affected.
- Section 6. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication pursuant to Section 1.08.017, Kirkland Municipal Code in the summary form attached to the original of this ordinance and by this reference approved by the City Council.

SECTION 1. Amends the Sunset provision of Ordinance O-4733.

SECTIONS 2 - 3. Amend the Development Agreement initially adopted by Resolution R-5140.

SECTION 4. Requires this Ordinance to be recorded on the property.

<u>SECTION 5</u>. Provides a severability clause for the ordinance.

<u>SECTION 6</u>. Authorizes publication of the ordinance by summary and establishes the effective date as five days after publication of summary.
