ORDINANCE 0-4903

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO ZONING AND LAND USE AND AMENDING THE CITY OF KIRKLAND ZONING MAP TO REZONE CERTAIN PARCELS TO PARK/OPEN SPACE; FILE NOS. CAM25-00072 AND CAM25-00076.

WHEREAS, the City Council received a recommendation from the Kirkland Planning Commission to amend the Kirkland Zoning Map, Ordinance 3710, as amended, and as set forth in the staff report dated May 6, 2025, containing the recommendation of the Planning Commission and bearing Kirkland Planning and Building Department File No. CAM25-00072 and No. CAM25-00076; and

WHEREAS, prior to making the recommendation, the Planning Commission, following notice thereof as required by RCW 35A.63.070, held a public hearing on March 13, 2025, on the amendment proposal and received one public comment at the hearing supporting the Finn Hill zoning map amendment and no public comments about the former Houghton Park & Ride zoning map amendment; and

WHEREAS, pursuant to the State Environmental Policy Act (SEPA), there has been a SEPA Addendum to the 2015 Comprehensive Plan Update & Totem Lake Planned Action Ordinance Final Environmental Impact Statement issued on March 6, 2025, by the responsible official pursuant to WAC 197-11-625; and

WHEREAS, in a public meeting on May 20, 2025, the City Council considered the SEPA determination made by the City's SEPA Responsible Official and the Planning Commission recommendation; and

WHEREAS, rezoning the former Houghton Park & Ride parcels and several Cityowned parcels in the Finn Hill neighborhood acquired in 2024 to the Park/Open Space (P) zoning designation will create opportunity for future uses of those properties as parks, open space, or recreational facilities; and

WHEREAS, creating more land that is zoned as park land is consistent with the City of Kirkland's 2044 Comprehensive Plan

NOW, THEREFORE, the City Council of the City of Kirkland do ordain as follows:

<u>Section 1.</u> The Kirkland Zoning Map is hereby amended to revise the zoning designations of the parcels listed and depicted in Exhibit A to this ordinance, which is incorporated by this reference, to the Park/Open Space (P) zone.

<u>Section 2</u>. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance or the application of the provision to other persons or circumstances is not affected.

Section 3. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication in the summary form attached to the original of this ordinance and by this reference approved by the City Council.

<u>SECTION 3</u>. Authorizes publication of the ordinance by summary and establishes the effective date as five days after publication of summary.


