Be it ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND:

1. That it is the intention of the Town Council to order the

improvement of KIRKLAND AVENUE from LAKE AVENUE to City Limits, on the North side,

and from Blau's Chevrolet Co. garage property to the South side

of State Aid Road, by putting in cement sidewalks and curbs; and

STATE AID ROAD on the East and North side to City Limits, by put-

ting in cement sidewalks, with culverts and proper crossings,

*and grading said State Aid Road from from Kirkland and Electric line of
factory.*

information required by law to be submitted.

4. That the cost and expense of said improvement shall be borne

by and assessed against the property liable therefor, as provided by

law.

RESOLUTION NO. 108

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND:

1. That it is the intention of the Town Council to order the improvement of Morton Avenue from Jersey Street to Market Street, by grading, gravelling and proper drainage and doing such other work as may be necessary in connection therewith, all in accordance with plans prepared by the Engineer employed by the Town of Kirkland.

2. That all persons who may desire to object thereto are hereby notified to appear and present such objections at a meeting of the Town Council to be held in the Council Chamber in the Town of Kirkland at Eight o'clock P.M. on the 20th day of April 1925, which time and place is hereby fixed for hearing all matters relating to said proposed improvement, and all objections thereto and for determining the method of payment for said improvement.

3. That the Town Engineer shall, in the manner provided by law, submit to the Town Council, at or prior to said date, all data and information required by law to be submitted.

4. That the cost and expense of said improvement shall be borne by and assessed against the property liable therefor, as provided by law.
