

RESOLUTION NO. 109.

BE IT RESOLVED BY THE TOWN COUNCIL OF KIRKLAND :

Section 1: That whereas an emergency exists in the water system in the town of Kirkland, said system being owned by said town, and being in danger of becoming polluted, and an inadequate supply being available for summer use, it is resolved by said Council to request, and they do hereby request the election board of King County Washington to call a special election in the town of Kirkland to vote on the question of becoming indebted and issuing general bonds in the sum of \$15000.00 to raise revenue to make the necessary improvements.

Section 2: That said proposition was voted on at the general election held in said town on March 10, 1925, but on account of sickness in said town and lack of understanding of the law there was an insufficient number who voted on the said bond issue; the total number voting being 291, out of which 205 voted in favor of the issue and 42 voted against the issue, making a total of 247 voting on the bond issue which is not 50% of the total number of votes cast at the last general election.

Section 3: That the attorney for the said town be and he is hereby authorized to employ such help as may be necessary for the calling of a special election for the purpose of voting on said bond issue and doing all necessary work preparatory to the issuance of said bonds for the improvement of said water system.

NOTICE TO BIDDERS.

NOTICE IS HEREBY GIVEN THAT sealed bids will be received by the undersigned Town Clerk of the Town of Kirkland, for the improvement of Lake Avenue between Market Street and the west side of Park Street by grading, graveling and putting in proper culverts for drainage and such other work as may be necessary thereto, in accordance with ordinance number 245 of said Town and the plans and specifications of the Town engineer which are now on file and open to inspection with the Town clerk.

Said bids will be received up to 5:00 o'clock P.M. May 18 1925 at the office of the undersigned Town clerk. Each bid must be accompanied by a certified check for ten per cent of the amount thereof made payable to the Town of Kirkland and the same to be forfeited to the Town in case the successful bidder fails to enter into a contract and furnish the bond herein required and provided for.

The successful bidder will be required to enter into a written contract pursuant to said bid and furnish a good and sufficient bond to the said Town conditioned for the faithful performance thereof, in an amount equal to the contract price for said work, all within ten days after the acceptance of said bid.

The Town Council reserves the right to refuse any and all bids. Special attention is called to the number of hours constituting a days work under the State law.

The successful bidder will also be required to make all payments to the State of Washington, which may be required by reason of the "Workmans Compensation Act."
