

RESOLUTION NO. 114

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND:

SECTION 1. That it is the intention of the Town Council of the Town of Kirkland to order the improvement of: - *Kirkland Ave. from Lake Ave to intersection of Kirkland Ave & State Aid Road, and State Aid Road to City Limits, by grading, graveling & drainage*

and such other work as may be necessary thereto, in accordance with the plans and specifications of the Engineer in the employ of the Town of Kirkland.

Section 2. That it is the intention of the Town Council of the said Town to include this improvement in and combine it with Local Improvement District No. 74 heretofore created and to amend ordinance No. 247 to include all property benefitted by said proposed improvement

SECTION 3. That all persons who may desire to object thereto are hereby notified to appear and present such objections at a meeting of the of the Town Council to be held in the Council Chambers in the Town of Kirkland at 8:00 o'clock P.M. on the 26th day of June, 1925, which time and place is hereby fixed for hearing all matters relating to said proposed improvement, and all objections thereto, and for determining the method of payment for said improvement.

SECTION 4. That the Town Engineer will in the manner provided by law submit to the Town Council, all or prior to said date, all data and information required by law to be submitted.

SECTION 5. That the cost and expense of said improvement will be borne and assessed against the property liable therefore as provided by law.
