

RESOLUTION NO. 116.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND:

SECTION. 1. That it is the intention of the Town Council of the Town of Kirkland to order the improvement of the State Aid Road by putting in concrete curb and gutter on the North and East side of the State Aid Road to the City Limits and the South side from the intersection of Kirkland Avenue and the State Aid Road to Jackson Street by putting in cement sidewalk curb and gutter and such other work as may be necessary thereto in accordance with the plans and specifications of the Engineer in the employ of the Town of Kirkland.

SECTION 2. That it is the intention of the said Town to include this improvement in and combine it with Local Improvement District No. 74 as created by Ordinance 256 and to include all property benefitted by said improvement.

SECTION. 3. That it is the opinion of the Town Council of the Town of Kirkland that the benefits derived from said improvement will extend beyond the boundaries of Local Improvement District No. 74 as created and setout in Ordinance No 256 and that it is necessary and proper to inlarge said district to include all property on the East side of the State Aid Road to the City Limits and on the West side of the State Aid Road to a line running paralel with the West side of Elm Street from Kirkland Avenue to the City Limits.

SECTION. 4. That the District as created under Ordinance No. 256 shall be assessed in the sum of \$17000.00 of the cost and expense of said improvement, and that such portion of the remainder of the cost and expense as is not borne by and general fund, shall be distributed and assessed against all the property included in the remainder of such enlarged district in accordance with the special benefits.

SECTION. 5. That all persons who may desier to object thereto are hereby notified to appear and present such objections at a meeting of the Town Council to be held in the Council Chambers of the Town of Kirkland at 8 o'clock P.M. on the 3rd day of August, 1925, which time and

and place is hereby fixed for hearing all matters relating to said improvement, and all objections thereto and determining the method of payment of said improvement.

SECTION 6. That the Town Engineer will in the manner provided by law submit to the Town Council, at, or prior to said date all data and information required by law to be submitted.

SECTION.7. That the cost and expense of said improvement will be borne and assessed against the property liable therefore as provided by law.

NOTICE OF ASSESSMENT.

Improvement of Lake Avenue by grading, graveling, putting in proper culverts under L.I.D. NO. 73 Ordinance NO. 245.

Notice is hereby given that the assessment roll for the improvement of Lake Avenue between Market Street and the West side of Park Street by grading, graveling, putting in proper culverts and such other work as may be necessary thereto all in the Town of Kirkland, comprising Local Improvement District No. 73 under Ordinance No. 245 is in my hands for collection, and any assessments thereon or any portion of any such assessment may be paid at any time within thirty (30) days from the date of the first publication of this notice, without penalty, interest or costs, and unless payment is made within such time such assessment or unpaid portion thereof will become delinquent. Upon delinquency a penalty of 5% will attach and become a part of such assessment. Delinquent assessments will bear interest at the rate of 7% per annum until paid. Such delinquent assessment with penalty and interest will forthwith be collected and the lien thereof be enforced in the manner provided by law.
