

RESOLUTION NO.117.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND:-

Section 1. That the 31 day of Aug., 1925, at 8 o'clock P.M. is hereby fixed as the date of hearing on Local Assessment Roll for Local Improvement District No.74; for the improvement of Kirkland Avenue from Lake Ave. to the City limits on the North side and from Blau Chevrolet Garage Property on the South side to the intersection of the said Kirkland Ave. and the State Aid Road by putting in cement sidewalks with curbs and gutters and proper drainage, and the State Aid Road on the North and East side to the City limits and on the South and West side from the intersection of Kirkland Ave. and the State Aid Road to Jackson Street by putting in cement sidewalk with curb and gutter and proper drainage; and by grading and graveling Kirkland Ave. form Lake Ave. to the City Limits and the State Aid Road from Kirkland Ave. to the City limits under Ordinance No. 261.

Section 2. That the Town Clerk be, and he hereby is directed to publish in the official newspaper of the Town of Kirkland, notice thereof as required by law.

NOTICE OF HEARING ON ASSESSMENT ROLL.

Improvement of Kirkland Ave and the State Aid Road by putting in Cement sidewalk and grading and graveling L.I.D. No. 74 Ordinance No. 261.

Notice is hereby given that the assessment roll for Local Improvement District No. 74, for the improvement of Kirkland Ave. from Lake Ave. to the City limits on the North side and from Blau Chevrolet Garage Property on the South side to the intersection of the said Kirkland Ave. and the State Aid Road by putting in cement sidewalks with curbs and gutters and proper drainage, and the State Aid Road on the North and East side to the City Limits on the South and West side from the intersection of Kirkland Ave. and the State Aid Road to Jackson Street by putting in cement sidewalk with curb and gutter and proper drainage; and by grading and graveling Kirkland Ave. from Lake Ave. to the City limits and State Aid Road from Kirkland Ave. to the City limits and such other work as may be necessary thereto, is now on file in the office of the Town Clerk.

Said roll has been set down for hearing at a special meeting of the Town Council to be held in the Council Chambers in the Town of Kirkland at 8:00 o'clock P.M. on the 31<sup>st</sup> day of August, 1925, and all persons who may desire to object thereto are notified to make such objections in writing and to file same with the Town Clerk at or prior to the date fixed for such hearing. At the time and place fixed and at such other times as the hearing may be continued to, the Council will sit as a Board of Equalization for the purpose of considering such roll, and at such hearing, or hearings, will consider such objections made thereto, or any part thereof, and will correct, revise, raise, lower, change or modify such roll, or any part thereof, or set aside such roll and order such assessment to be made de novo, as to such body shall appear just and equitable, and then proceed to confirm same by ordinance.
