

RESOLUTION. NO. 119

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND

Section 1. That it is the intention of the Town Council of the Town of Kirkland to order the improvement of:-- *Saba Ave, East Side from P.O. Bldg. to Jackson St. by:-- 6' cement sidewalk and curbing and paving from curb to present paving and such other work as may be necessary.*

~~and such other work as may be necessary~~ thereto, in accordance with the plans and specifications of the Engineer in the employ of the Town of Kirkland.

Section 2. That all persons desiring to object thereto are hereby notified to appear and present such objections at a meeting of the Town Council to be held in the Council chambers of the said Town at 8 o'clock P.M. on the 21<sup>st</sup> day of September, 1925, which time and place is hereby fixed for hearing all matters relating to said improvement, and all objections thereto, and for determining the method of payment for said improvement.

Section 3. The Engineer in the employ of said town, shall in the manner provided by law, submit to the Town Council, at or prior to said date, all data and information required by law to be submitted.

Section 4. That the cost and expense of said improvement shall be borne and assessed against the property liable therefore as provided by law.
