RESOLUTION R-5690

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING ADJUSTMENT OF THE BOUNDARY LINE BETWEEN THE CITY OF KIRKLAND AND THE CITY OF BELLEVUE, PURSUANT TO RCW 35.13.340, SO THE ENTIRETY OF THE CROSS KIRKLAND CORRIDOR PROPERTY IS LOCATED WITHIN THE MUNICIPAL BOUNDARIES OF THE CITY OF KIRKLAND.

WHEREAS, when a single parcel of land is partially located within the boundaries of two different cities, RCW 35.13.340 authorizes the adjustment of the municipal boundary line so that all of the parcel can be located within either of the cities, provided the boundary adjustment is requested in a petition signed by the property owner; and

WHEREAS, a boundary line adjustment under RCW 35.13.340 is not subject to the State Environmental Policy Act or review by the King County Review Board; and

WHEREAS, the parcel that constitutes the southern portion of the Cross Kirkland Corridor is presently located in both Bellevue and Kirkland, with the municipal boundary splitting the parcel; and

WHEREAS, the City of Kirkland, which is the titled owner of the Cross Kirkland Corridor (CKC), has submitted to the legislative bodies for both Kirkland and Bellevue a petition calling for an adjustment of the municipal boundary at the CKC parcel, requesting that the entirety of the CKC parcel be placed within the municipal boundary of Kirkland; and

WHEREAS, a boundary line adjustment placing the entirety of the CKC within the City of Kirkland will provide for clear jurisdictional boundaries.

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland as follows:

Section 1. Pursuant to RCW 35.13.340, the requested boundary line between the City of Kirkland and the City of Bellevue is hereby approved and, upon parallel approval by the City of Bellevue, it shall be so adjusted so as to include within the corporate boundaries of the City of Kirkland the remainder of the Cross Kirkland Corridor parcel that us currently located inside the City of Bellevue, as further depicted in Exhibit A and described in Exhibit B attached hereto and incorporated herein by this reference as if set forth in full.

<u>Section 2.</u> The City Manager or designee is hereby authorized to take all necessary administrative acts to finalize the boundary line adjustment as authorized herein.




EXHIBIT B
