

RESOLUTION NO. 166

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND:

SECTION 1. That whereas, it is the opinion of the Town Council of the Town of Kirkland that it is for the best interest of the Town of Kirkland to dispose of that portion of the Town Park, for the sum of \$ 8000⁰⁰, described as follows, to-wit:

to the Union A. High School District No. ~~71~~, King County, Wash.

SECTION 2: That in order to dispose of said property, as above set forth, it will be necessary to call a special election in the Town of Kirkland, now, therefore, be it resolved by the said council to request, and they do hereby request the election board of King County, Washington to call a special election in the Town of Kirkland to vote on the question of selling said park property to Union A. High School District No. ~~71~~, King County, Washington for the sum of \$ 8000⁰⁰ as above set forth.

That portion of vacated Blocks 3 and 4; of the vacated alley in Block 3; of vacated Park Street; and of vacated Lake Avenue, all in the Map of Kirkland, and of Government Lots 4 and 5, of Section 6, Township 25 North, Range 5 East, W.M. and the shore lands fronting thereon contained within the following description:-

Beginning at the intersection of the center lines of Market Street and Waverly Street in the Map of Kirkland, King County, Washington, according to plat recorded in Volume 6 of Plats, at pages 53 to 65 inclusive, of the records of said County; running thence along the center line of Waverly Street, North $46^{\circ}24'00''$ West, 200.00 feet; thence South $43^{\circ}36'00''$ West, 30.00 feet to the southeasterly corner of the Park and Playfield site; thence along the northeasterly boundary of said site (being also the southwesterly boundary of Waverly Street) North $46^{\circ}24'00''$ West, 360.00 feet to the true point of beginning of this description; thence South $43^{\circ}36'00''$ West, 336.62 feet to the northeasterly margin of Lake Avenue Extension as deeded by Burke & Farrar, Inc to the City of Kirkland and recorded in Volume 1163 of Deeds at page 479, records of King County, Washington; thence along said margin North $28^{\circ}30'00''$ West, 593.62 feet to the northwesterly corner of the Park and Playfield site; thence along the northwesterly boundary of said site; and its production, North $61^{\circ}30'00''$ East, 162.01 feet to a point on the northeasterly margin of said site; thence along said margin South $46^{\circ}24'00''$ East, 515.09 feet to the true point of beginning.
