

ORDINANCE O-4916

AN ORDINANCE OF THE CITY OF KIRKLAND AMENDING THE BIENNIAL BUDGET FOR 2025-2026.

WHEREAS, the City Council adopted Ordinance O-4895, on December 10, 2024, adopting the fiscal biennium budget for 2025-2026; and

WHEREAS, a public hearing on the proposed mid-biennial budget modifications was held before the City Council on November 5, 2025, following proper notice to the public; and

WHEREAS, the City Council has considered the proposed mid-biennial budget adjustments and any and all public comments received from the public with regard to the proposed modifications; and

WHEREAS, City Council finds that the proposed mid-biennial adjustments to the Biennial Budget for 2025-2026 reflect revenues and expenditures that are intended to ensure the provision of vital municipal services at acceptable levels.

NOW, THEREFORE, the City Council of the City of Kirkland do ordain as follows:

Section 1. The mid-biennial December 2025 adjustments to the Biennial Budget of the City of Kirkland for the years 2025-2026 are hereby adopted. In summary form, the totals of estimated revenues and appropriations for each separate fund and the aggregate totals for all such funds combined are as follows:

23 circumstance is held invalid, the remainder of the ordinance or the application of the provision
24 to other persons or circumstances is not affected.

25 Section 4. This ordinance shall be in force and effect five days from and after its
26 passage by the Kirkland City Council and publication, as required by law.




5 SECTION 2. Sets the total number of City Full Time Equivalents (FTE) positions.
