BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND AS FOLLOWS:

THAT WHEREAS, the City of Kirkland has this day granted to the Lake Washington Transit Lines, Inc. a certain bus franchise over and upon the streets of the City of Kirkland and such company shall commence operation within sixty (60) days from the effective date of said Ordinance, and

WHEREAS, said Ordinance provides that the City Council by resolution shall jointly, with the said Company, from time to time fix exact routes and schedules of said bus operations within the City of Kirkland.

NOW, THEREFORE, said City Council does hereby fix and establish the time schedules and routes of said Lake Washington Transit Lines, Inc. as set forth in Exhibit "A" attached hereto and by this reference incorporated herein.
