BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND AS FOLLOWS:

THAT WHEREAS, there has been continued request to the City of Kirk-land for street improvements and the matter having been considered, preliminary hearing had by the City Council of the City of Kirkland, and

WHEREAS, an area as hereinafter specifically set forth has been designated as a proposed Local Improvement District for the construction of concrete walks and curbs, and the grading and graveling of streets including any necessary adjustment of manholes and other utilities, now, therefore,

IT IS RESCLVED AND DECLARED:

The City Council of Kirkland proposes and hereby resolves to create a Local Improvement District for the construction of concrete walks and curbs and the grading and graveling of streets including any necessary adjustment of manholes and other utilities in the District comprised of the following streets:

Waverly Way from Market Street to the North line of Block 22, Town of Kirkland Addition.

10th Avenue West, 8th Ave. West, 7th Ave. West, and 5th Ave. West, from Waverly Way to Market St.

Lake Ave. West from 2nd St. West to Market Street, Southwest side only. 2nd Street West and 3rd St. West from Waverly Way to Market Street.

4th St. West, 5th St. West, and 6th St. West from Waverly Way to the alley North of 10th Ave. West.

lst St., 2nd St. and 3rd St. from Central Way to 18th Ave.
18th Ave., 15th Ave., 13th Ave., 10th Ave., 9th Ave., 8th Ave., 7th
Ave., 6th Ave., 5th Ave. from Market St. to 3rd St.
16th Ave., 14th Ave., 12th Ave., 11th Ave. from Market St. to 2nd St.
4th Ave. from Market St. to the alley East of 1st St. and from 2nd St. to 3rd St. 3rd Ave. and its extension from 1st St. to Central Way.

- 2. Notice is hereby given to all persons who desire to object to the proposed Local Improvement District to appear at a meeting of the kirkland City Council at the Council Chambers, Kirkland City Hall, Kirkland, Washington, on July 12, 1948.
- 3. The City Council requests and directs City Engineer, Harry Sisler, to submit to the City Council on or before the date of said hearing, the estimated cost and expense of the Improvement proposed, with a statement of the proportionate amount thereof to be borne by the property within the proposed assessment district.
- 4. It is requested also that a statement be furnished by the City engineer of the aggregate assessed valuation of the real estate, exclusive of improvements, within said district according to the valuation also placed upon it for the purposes of general taxation, together with a diagram or print showing thereon the lots, tracts and parcels of land and other property which will be specially benefited thereby and the estimated amount of the cost and expense of such improvement to be borne by each lot, tract, or parcel of land or other property.
- 5. The City Council further directs that notice of the above designated hearing shall be given to each owner or reputed owner of any lot, tract, or parcel of land or other property specially benefited by the improvement in accordance with the laws of the State of Washington.
