

RESOLUTION NO. 393

A RESOLUTION of the Council of the City of Kirkland, Washington, correcting the minutes of the meeting of said Council for December 20, 1948.

WHEREAS, the minutes of the meeting of the City Council of December 20, 1948 are ambiguous and incomplete in describing the work to be done in improving Market Street and other streets connecting therewith and in the vicinity thereof by the construction of concrete walks and curbs and the grading and graveling of streets, including any necessary adjustment of manholes and other utilities, and by doing such other work as may be necessary in connection therewith; and

WHEREAS, it is deemed necessary that the Council order a correction of said minutes to properly describe such improvements;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Kirkland, Washington, as follows:

Section 1. That it is hereby ordered that the ninth paragraph of the minutes of the meeting of the City Council of December 20, 1948, be and the same are hereby corrected to read as follows:

The following described streets shall be improved by the construction of concrete walks and curbs and grading and graveling, including any necessary adjustment of manholes and other utilities, and by doing such other work as may be necessary in connection therewith, all in accordance with plans prepared by the city's engineers and now on file in the office of the City Clerk:

- (1) Market Street from Central Way to 18th Avenue
- (2) Waverly Way from Market Street to the north line of Block 22, Town of Kirkland Addition.
- (3) 10th, 9th, 7th, and 5th Avenues West from Waverly Way to Market Street.
- (4) 11th Avenue West from Market Street to a point approximately 300 feet west of 6th Street West.
- (5) 2nd and 3rd Streets West from Waverly Way to Market Street.
- (6) 4th, 5th and 6th Streets West from Waverly Way to the alley north of 11th Avenue West.
- (7) 1st Street from Central Way to 16th Avenue.
- (8) 2nd Street from Central Way to 10th Avenue.
- (9) 3rd Street from Central Way to 7th Avenue.
- (10) 10th, 9th and 8th Avenues from Market Street to 2nd Street.
- (11) 7th, 6th, 5th, 4th and 3rd Avenues from Market Street to 3rd Street.
- (12) 16th, 15th, 14th, 13th, 12th and 11th Avenues from Market Street to 1st Street.

EXCEPT FOR the following:

- (1) That a sidewalk shall not be constructed on the south side of Waverly Way.
- (2) That a sidewalk shall not be constructed on the north side of the triangle located at 10th Avenue West and 6th Street.
- (3) That a sidewalk shall not be constructed on the northeast and southeast sides of the triangle located at Waverly Way and 9th Avenue West.
- (4) That a sidewalk shall not be constructed on the northwest side of the triangle located at Market Street and 10th Avenue West.
- (5) That sidewalks shall not be constructed on 11th Avenue West and 6th Street West to the west end of 11th Avenue West.
