

A RESOLUTION OF THE CITY OF KIRKLAND TO
INITIATE ANNEXATION PROCEEDINGS
IN SUBSTITUTION FOR RESOLUTION NO. 470



THE CITY COUNCIL OF THE CITY OF KIRKLAND DO HEREBY RESOLVE
AS FOLLOWS:

1. It appearing that RESOLUTION NO. 470 of the CITY OF KIRKLAND, entitled "A RESOLUTION OF THE CITY OF KIRKLAND TO INITIATE ANNEXATION PROCEEDINGS", erroneously described the contiguous territory sought therein to be annexed, therefore, the CITY OF KIRKLAND does hereby substitute for RESOLUTION NO. 470 the following:
2. That the best interests and general welfare of the CITY OF KIRKLAND will be served by annexation to the CITY OF KIRKLAND of the hereinafter described territory, contiguous to the CITY OF KIRKLAND.
3. That the estimated number of voters residing in said area is 1300.
4. That the CITY does hereby pray the calling of an election to be held among the qualified voters residing in said area upon the question of annexation to the CITY OF KIRKLAND and, further, upon the proposition that all property within said area shall, upon annexation, be assessed and taxed at the same rate and on the same basis as the property presently within the CITY OF KIRKLAND is assessed and taxed, to pay for any currently outstanding indebtedness of the CITY OF KIRKLAND existing at the date of such annexation.
5. That the cost of such election shall be borne by the CITY OF KIRKLAND.
6. That said area is situate in the County of King, State of Washington, is contiguous to the City of Kirkland, and is described as follows:

"Commencing at that certain point on the present Kirkland City Limits, being the Northwest corner of the intersection of Northeast 100th (18th Avenue in Kirkland) and 116th Avenue Northeast; thence Southeasterly to the Southwest corner of Section 33, Township 26 North, Range 5, E.W.M., thence East along the South boundary of said Section 33, to the Southeast corner of said Section 33 and its intersection with the centerline of 132nd Avenue Northeast; thence North along the East line of Section 33 and Section 28, Township 26 North, Range 5, E.W.M., to the intersection of said East line with the centerline of Northeast 132nd; thence West along the centerline of Northeast 132nd to its point of intersection with the centerline of the right-of-way of State Highway No. 1- RE; thence South along said centerline of the right-of-way of State Highway No. 1-RE to its intersection with the Easterly boundary of the Northern Pacific Railway right-of-way; thence Southwesterly along said Easterly boundary of the Northern Pacific Railway right-of-way to its intersection with the present easterly City Limits of the City of Kirkland, as established by Kirkland City Ordinance No. 810; thence southerly along the easterly City Limits of the City of Kirkland to the point of beginning."


