

CITY OF KIRKLAND RESOLUTION No. 542

SUPPLEMENTAL AGREEMENT NO. 7
TO THE
INTERGOVERNMENTAL AGREEMENT ON THE ACQUISITION AND PRESERVATION OF OPEN SPACE
IN THE CENTRAL PUGET SOUND REGION

This SUPPLEMENTAL AGREEMENT is made between the members of the Puget Sound Governmental Conference, a public body created pursuant to Chapter 36, Laws of 1959, as amended, and Chapter 84, Laws of 1965, Extraordinary Session, and the City of Kirkland.

WHEREAS, The participating members of the Puget Sound Governmental Conference entered into an INTERGOVERNMENTAL AGREEMENT on the 6th day of March, 1963, and amended the 17th day of November, 1965, providing that each member will participate in a regional comprehensive planning program for the purpose of preservation of open space land, and

WHEREAS, In Section III of the March 6, 1963, as amended November 17, 1965, INTERGOVERNMENTAL AGREEMENT, it is provided that additional public bodies may from time to time become part of and participate in the INTERGOVERNMENTAL AGREEMENT, and

WHEREAS, The City of Kirkland on the 20th day of December, 1965, did pass a resolution agreeing to comply with the terms of the INTERGOVERNMENTAL AGREEMENT, and

WHEREAS, By letter dated December 27th, the City of Kirkland did officially request membership in the INTERGOVERNMENTAL AGREEMENT, and

WHEREAS, The Puget Sound Governmental Conference approved this request on the 17th day of November, 1965;

NOW, THEREFORE, the City of Kirkland does hereby agree to become part of the INTERGOVERNMENTAL AGREEMENT ON THE ACQUISITION AND PRESERVATION OF OPEN SPACE IN THE CENTRAL PUGET SOUND REGION dated the 6th day of March, 1963, as amended the 17th day of November, 1965, and said City of Kirkland does hereby agree to become bound by all the terms and conditions set forth in said INTERGOVERNMENTAL AGREEMENT, and said INTERGOVERNMENTAL AGREEMENT and all the terms and conditions thereof are hereby incorporated into and made a part hereof as though it were fully set forth in this SUPPLEMENTAL AGREEMENT, and the Puget Sound Governmental Conference does hereby approve and accept the City of Kirkland as a participating member of said INTERGOVERNMENTAL AGREEMENT.

IN WITNESS WHEREOF, the City of Kirkland and the Puget Sound Governmental Conference have caused this SUPPLEMENTAL AGREEMENT to be executed as follows:
