
WHEREAS, in the improvement of Primary State Highway No. 1 (SR 405) Northrup Interchange to N.E. 140th Street by the State of Washington, Department of Highways, it is necessary and advisable for the State of Washington to acquire title to a portion of said lands (as described in deed of even date) for a right of way for said highway; and

WHEREAS, after due consideration by the Mayor and Council of the City of Kirkland, it appears to said Mayor and Council that it will be in the best interest of both the City of Kirkland and the State of Washington that said Mayor and Council convey said lands to the State of Washington by quit claim deed for a consideration of EIGHTY FIVE THOUSAND FIVE HUNDRED AND NO/100 (\$85,500.00) DOLLARS;


