RESOLUTION NO. 2077 OF THE CITY OF KIRKLAND AND NOTICE OF HEARING STREET VACATION.

WHEREAS, a petition has been filed with the City of Kirkland signed by owners of interest in real property representing more than two-thirds of the property abutting upon the hereinafter described street, and

WHEREAS, it appears that the public interest to the City of Kirkland, Washington may be served by the vacation of said street.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland:

1. That a public hearing be held to consider whether the public interest and general welfare of the City of Kirkland will be served by the vacation of that certain street situate in Kirkland, King County, Washington, and described as follows:

Beginning at the northwesterly corner of Lot 33, Block 102, Burke & Farrar's Add. Div. 25 as recorded in Vol. 25, Page 14 of Plats, records of King County, Wash., thence N 36°37'00" E 8.07 feet; thence S. 01°39'30" E 12.88 feet; thence along a curve to the right, thru a central angle of 38°30'45" with a radius of 50 feet, an arc distance of 33.61 feet; thence S. 36°51'15" W 86.44 feet; thence along a curve to the left, thru a central angle of 72°00'45", with a radius of 20 feet, an arc distance of 25.14 feet; thence S. 35°09'30" E. 49.70 feet; thence on a curve to the right, thru a central angle of 33°30'00", with a radius of 50 feet, an arc distance of 29.23 feet, thence S. 01°39'30" E 21.47 feet to the northerly margin of 2nd Avenue South; thence S. 88°20'30" W along the northerly margin of 2nd Avenue South 30 feet; thence N. 01°39'30" W 21.47 feet; thence along a curve to the left, thru a central angle of 33°30'00" with a radius of 20 feet, an arc distance of 11.69 feet; thence N. 35°09'30" W 49.70 feet; thence along a curve to the right, thru a central angle of 72°00'45", with a radius of 50 feet, an arc distance of 62.84 feet; thence N. 36°51'15" E 86.44 feet; thence N. 01°39'30" W 1.68 feet to the southerly margin of 1st Avenue South; thence along said southerly margin of 1st Avenue South; thence along said southerly margin N. 88°20'30" E 4.68 feet; thence N. 55°12'18" E 29.86 feet to the point of beginning.

Said street is commonly known as relocated Second Street South, lying between First Avenue South and Second Avenue South in the City of Kirkland.

2. That said public hearing will be held before the Kirkland City Council in its chambers at the Kirkland City Hall on February 1, 1971 at 8:00 P.M.
