

RESOLUTION NO. 2102

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND RATIFYING A CALL FOR BIDS MADE BY THE CITY FOR CONCRETE SIDEWALKS AND DRIVEWAY ALONG LAKE WASHINGTON BOULEVARD AS PART OF THE IMPROVEMENTS OF LOCAL IMPROVEMENT DISTRICT NO. 105 AUTHORIZING THE DIRECTOR OF PUBLIC SERVICES UNDER CERTAIN CONDITIONS TO AWARD CONTRACT AND GIVE NOTICE TO PROCEED, AND UNDER SAID CONDITIONS AUTHORIZING THE MAYOR TO SIGN SAID CONTRACT ON BEHALF OF THE CITY.

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

WHEREAS, the City of Kirkland has by local improvement district creation determined to convert the telephone and electrical facilities along Lake Washington Boulevard and Lake Street South (SR-901) to underground with all conversion work to be done in coordination with the State Highway Department improvement project now being constructed by West Coast Construction Company, Inc., under contract with the State Highway Department, and

WHEREAS, in order to accomplish this conversion with a minimum of improvement conflicts and within the time and financial budget available, the best efforts and cooperation from all parties is required. For example, the joint use of excavations for street drainage improvements and utility conversion improvements, the coordination of improvement placements and single restorations, wherever possible, are mandatory, and

WHEREAS, in the opinion of the Director of Public Services, it became necessary to advertise and call for bids for restoration of concrete sidewalks and driveways along Lake Washington Boulevard, and

WHEREAS, he did so call, and


WHEREAS, the Council concurs that the time schedule, percentage of completion and weather, together with other pertinent factors, dictate that concrete sidewalk and driveway restorations should be commenced and completed as rapidly as possible,

NOW, THEREFORE,


Section 1: The call for bids for concrete sidewalks and driveway along Lake Washington Boulevard made by the City previously and set for opening on July 22, 1971, is hereby approved. In the event bids received clearly reflect a single low bidder whose bid does not exceed the sum of \$23,000.00, then in that event the Director of Public Services is hereby authorized to award contract to such low bidder and to give to such low bidder forthwith notice to proceed.

Section 2: The Mayor shall also be authorized under the conditions set forth in Section 1 above, to sign on behalf of the City a contract for such work, subject to ratification by the City Council at their next regular meeting.
