WHEREAS, a special condition of that grant is that the land so acquired or any interest therein be not sold, leased or otherwise transferred without the prior written approval of the Secretary of Housing and Urban Development, his designee or successor thereto, and that such restriction be recorded for the purpose of giving constructive notice, now, therefore,

BE IT RESOLVED by the City Council of the City of Kirkland as follows:


Section 1: The property acquired by the City of Kirkland and described in Section 2 of this Resolution, or any interest therein, shall not be sold, leased or otherwise transferred by the City of Kirkland without prior written approval of the Secretary of Housing and Urban Development, his designee or successor thereto, in accordance with the special condition required by paragraph No. 88 of HUD Guide No. 6240.3, which is a part of the contract between the Department of Housing and Urban Development and the City of Kirkland identified as Contract No. Wash-OSC-51 North Kirkland Community Park.

Section 2: Said properties are described as follows:

Tracts 1 through 8, inclusive of Kirkland-Juanita Acre Tracts, according to plat thereof recorded in Volume 16 of Plats, Page 63, Records of King County, Washington. All of said property is situate in Kirkland, King County, Washington.


Section 3: The Director of Administration and Finance is authorized and directed to record with the King County Auditor a certified copy of this Resolution, and to then forward a copy of this Resolution bearing the King County recording data to the Seattle area office for the Department of Housing and Urban Development, Region X.

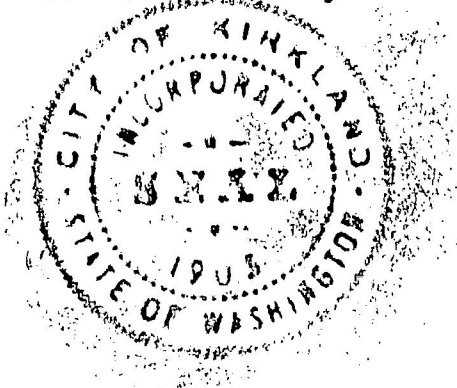
