A RESOLUTION OF THE KIRKLAND CITY COUNCIL RELATING TO PROPERTY DONATED TO THE CITY BY LOUIS S. MARSH, AND PLACING THEREON THE RESTRICTIVE COVENANT REQUIRED BY THE INTERAGENCY COMMITTEE FOR OUTDOOR RECREATION.

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1: The hereinafter described real property donated to the City of Kirkland by Louis S. Marsh is hereby declared to be subject to the following restrictive covenant as required by the Interagency Committee for Outdoor Recreation of the State of Washington: The City of Kirkland holds the hereinafter described real property subject to the obligations of the Project Agreement Contract between it and the Washington State Interagency Committee for Outdoor Recreation dated December 20, 1971, copies of which are in possession of the City of Kirkland and the Interagency Committee. The Project Agreement Contract provides, among other things, that the City shall not at any time convert this property to uses other than for which state assistance was originally granted, unless it has obtained prior approval of the Interagency Committee for Outdoor Recreation in the manner required by RCW 43.99.100, for marine recreation land, whether or not said property is marine recreation land.

Said real property is described as follows:

That portion of the following described property lying westerly of Lake Washington Boulevard N.E. as the same is now established:

The North 115 feet of the South 312 feet of Government Lot 3, Section 8, Township 25 North, Range 5 E.W.M., together with shorelands of the second class lying between the westerly extensions of the north and south lines of said portion of Government Lot 3, all within Kirkland, King County, Washington.

Section 2. The Director of Administration and Finance (ex officio City Clerk) is hereby authorized and directed to record a certified copy of this Resolution with the King County Department of Records and Elections.
