

RESOLUTION NO. 2122

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND DIRECTING THE DIRECTOR OF ADMINISTRATION AND FINANCE (EX OFFICIO CITY CLERK) FOR THE CITY OF KIRKLAND TO GIVE BY MAIL NOTICE TO ALL OWNERS WITHIN LOCAL IMPROVEMENT DISTRICT NO. 105 TO CONVERT THEIR ELECTRICAL AND COMMUNICATION FACILITIES FROM OVERHEAD TO UNDERGROUND.


WHEREAS, the City of Kirkland has now received notice in writing from Puget Sound Power and Light Company that the installation of underground electrical and communication facilities within Local Improvement District No. 105 (Lake Washington Boulevard) has been completed, and said underground facilities have been energized, now, therefore,

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The Director of Administration and Finance (ex officio City Clerk) for the City of Kirkland is hereby authorized and directed to give notice by mail and publication as required by statute to all property owners within Local Improvement District No. 105 to convert to the underground facilities within 90 days from the date of mailing of said notice. The notice to be mailed and published shall be substantially in the form attached to this Resolution and by this reference incorporated herein.


Section 2. Pursuant to RCW 35.96.050, the City Council is required to conduct a hearing to determine whether the removal of all or any part of the overhead service lines is in the public benefit, but said hearing is required to be held only if one or more written objections to connection to the underground facilities are filed by property owners within the local improvement district within 30 days of the date of mailing the notice to connect to underground facilities. In the event the City Council shall be required to hold such hearing, the hearing is hereby set for June 5, 1972, at 8:00 PM. In the event such hearing is required to be held, the Director of Administration and Finance (ex officio City Clerk) is hereby authorized and directed to give notice substantially in the form attached hereto as Exhibit B in the manner prescribed by law.

CITY OF KIRKLAND NOTICE OF HEARING LOCAL IMPROVEMENT DISTRICT NO. 105, CITY OF KIRKLAND, WASHINGTON - REMOVAL OF OVERHEAD UTILITY FACILITIES.
