RESOLUTION NO. 2131

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND TO INITIATE PURSUANT TO RCW 35A.14.015 CERTAIN ANNEXATION PROCEEDINGS.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND AND RESOLVE:

Section 1. The best interests and general welfare of the City of Kirkland will be served by annexation to the City of Kirkland of the hereinafter described territory contiguous to the City of Kirkland.

Section 2. Pursuant to Section 35A.14.015, Revised Code of Washington, the city does hereby call for an election to be held among the qualified voters residing within the said area upon the question of annexation to the City of Kirkland.

Section 3. The estimated number of qualified voters residing in said area as of May, 1972, is 148. The estimated assessed valuation of said area as of May, 1972, is \$1,791,742.00.

Section 4. The City Council does hereby determine that should such area be hereinafter annexed to the City of Kirkland, the property within said area shall not be assessed and taxed to pay for any outstanding indebtedness of the City of Kirkland existing at the date of such annexation.

Section 5. The cost of the election herein called for shall be borne by the City of Kirkland.

Section 6. The area proposed for annexation is situate in King County, State of Washington, is contiguous to the City of Kirkland, and is described as follows:

The following described property located within Section 9, Township 25 Range 5 East W. 19 and within Section 16, Township 25 Range 5 E.W.M., more specifically described as follows:

Beginning at the northwest corner of the southeast quarter of Section 9, Township 25, Range 5 E.W. 19, thence eastwardly along the north line of said southeast quarter a distance of approximately 1,110 feet to the point of intersection with the centerline of Macadone Road more commonly called NE 70th Place, thence continue southeasterly along said centerline to the east boundary of Section 9, Twp. 25, Range 5 East W.M., thence south along said east boundary to the southeast corner of said Section 9, thence west along the south line of Section 9, Twp 25, Range 5 East W.M. a distance of approximately 1,317 feet to the point of intersection with the centerline of 128th Avenue NE a point common with the northeast corner of the northwest quarter of the northeast quarter of Section 16, Township 25 Range 5 E.W.M, thence south along the east line of said northwest quarter of the northwest quarter of Section 16, Township 25, Range 5 E.W.M. to the southeast corner of said northwest quarter, thence westerly along the south line of northwest quarter of northeast quarter

of Section 16, Township 25, Range 5 E.W.M. to the southwest corner of said northwest quarter a point of intersection with the existing Kirkland city limits established by Ordinance No. 2066 thence north along the existing city limits, also the west line of the northwest quarter of the northeast quarter of Section 16, Township 25, Range 5 E.W.M., to the northwest corner of said northwest quarter, a point of intersection with the Kirkland City Limits (Houghton Municipal Community) as established by Ordinance No. 2001, thence continue northerly along the existing city limits also the west line of the southeast quarter of Section 9, Township 25, Range 5 E.W.M., to the northwest corner of the southeast quarter of Section 9, Township 25, Range 5 E.W.M., the point of beginning.

Section 7. A certified copy of this resolution shall be filed with the King County Council and with the King County Boundary Board of Review. Further copies may be filed with such other King County Departments and Boards as the City Manager may designate.
