

RESOLUTION NO. 2141

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AMENDING TO CORRECT CERTAIN TYPOGRAPHICAL ERRORS THE LEGAL DESCRIPTION SET FORTH IN SECTION 6 OF RESOLUTION NO. 2131 ADOPTED JUNE 5, 1972, AND ENTITLED: "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND TO INITIATE PURSUANT TO RCW 35A.14.015 CERTAIN ANNEXATION PROCEEDINGS".

THE CITY COUNCIL of the City of Kirkland does hereby resolve:

Section 1. Section 6 of Resolution No. 2131 adopted June 5, 1972, and entitled: "A Resolution of the City Council of the City of Kirkland to Initiate Pursuant to RCW 35A.14.015 Certain Annexation Proceedings" be and it hereby is amended to read as follows, in order to correct certain typographical errors contained in the legal description set forth in said section:

Section 6. The area proposed for annexation is situate in King County, State of Washington, is contiguous to the City of Kirkland, and is described as follows:

The following described property located within Section 9, Township 25 North, Range 5 EWM and within Section 16, Township 25 North, Range 5 EWM, more specifically described as follows:

Beginning at the northwest corner of the southeast 1/4 of Section 9, Township 25 North, Range 5 EWM, thence eastwardly along the north line of said southeast 1/4 a distance of approximately 1,110 feet to the point of intersection with the centerline of Macadone Road more commonly called N.E. 70th Place, thence continue south-easterly along said centerline to the east boundary of section 9, Twp 25 North, Range 5 EWM, thence south along said east boundary to the southeast corner of said Section 9, thence west along the south line of Section 9, Twp 25 North, Range 5 EWM a distance of approximately 1,317 feet to the point of intersection with the centerline of 128th Ave. N.E. a point common with the northeast corner of the northwest 1/4 of the northeast 1/4 of Section 16, Township 25 North, Range 5 EWM, thence south along the east line of said northwest 1/4 of the northeast 1/4 of Section 16, Twp 25 North, Range 5 EWM to the southeast corner of said northwest 1/4, thence westerly along the south line of said northwest 1/4 of the northeast 1/4 of Section 16, Twp 25 North, Range 5 EWM to the southwest corner of said northwest 1/4 a point of intersection with the existing Kirkland city limits established by Ordinance #2066, thence north along the existing city limits, also the west line of the northwest 1/4 of the northeast 1/4 of Section 16, Township 25 North, Range 5 EWM, to the northwest corner of said northwest 1/4, a point of intersection with the Kirkland City Limits (Houghton Municipal Community) as established by Ordinance #2001, thence continue northerly along the existing city limits also the west line of the southeast 1/4 of Section 9, Township 25 North, Range 5 EWM to the northwest corner of the southeast 1/4 of Section 9, Twp 25 North, Range 5 EWM, the point of beginning.

Section 2. Resolution No. 2131 is in all other respects
ratified and confirmed.
