RESOLUTION AND NOTICE OF HEARING

WHEREAS, The City, acting pursuant to Chapter 8, Volume IV, the Uniform Building Code, as adopted by the City in Chapter 21.28 of the Kirkland Municipal Code has caused certain work to be done as indicated in the report of the Director of Public Services attached to this resolution and by this reference incorporated herein, and

WHEREAS, pursuant to Chapter 9 of Volume IV, the Uniform Building Code, the City Council shall upon notice and hearing approve said report, determine whether the cost shall be assessed against the property owner as a personal obligation, or assessed as a charge against the real property involved and to provide for the collection thereof,

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland as follows:

Section 1. The date for hearing the attached report of the Director of Public Services is hereby set for June 4, 1973.

Section 2. A certified copy of this resolution, including the attached report, shall be served by certified mail with return receipt requested upon those persons named in said report as entitled to notice of said hearing pursuant to Section 401(c) of Volume IV, Uniform Building Code.

Section 3. In the event the Council shall determine the obligation to be a charge against the real property involved, the assessment therefor shall be confirmed by ordinance following said hearing. Such assessment shall be collected in the same manner as assessments for local improvement districts, be payable in five equal annual installments, shall bear interest at the rate of 10% percent per annum, and shall otherwise be subject to the provisions for penalty and collection provided by Sections 18.08.040 and 18.08.050 of the Kirkland Municipal Code.
