

RESOLUTION NO. 2187

A RESOLUTION OF THE KIRKLAND CITY COUNCIL AUTHORIZING AND DIRECTING THE MAYOR TO SIGN ON BEHALF OF THE CITY AS CONTRACTING PARTY THAT CERTAIN IAC PROJECT AGREEMENT: MARSH PARK DEVELOPMENT PROJECT NO. 73-059D.

WHEREAS, the Interagency Committee for Outdoor Recreation of the State of Washington has submitted to the City for its signature as contracting party the formal project agreement for IAC Project Marsh Park Development: IAC No. 73-059D, and

WHEREAS, the existing procedure adopted by the IAC is to submit the formal contract to the contracting party for signature prior to the actual approval of the proposed project and grant with the following understanding:

"If the proposed project of the contracting party is approved for funding assistance, the IAC Administrator will execute the contract on behalf of the IAC on the same day as committee approval. If the proposed project is not approved, the contract will be filed with the contracting party's application and returned to the contracting party."

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The Mayor of the City of Kirkland is hereby authorized and directed to sign on behalf of the City of Kirkland as contracting party that certain project agreement contract known and identified as Marsh Park Development: IAC Project No. 73-059D. A copy of said proposed project agreement has been attached to the original of this Resolution and by this reference incorporated herein.

Section 2. Pursuant to Section 21 of said project agreement, the liaison officer for the City of Kirkland is hereby designated as David Brink, Director of Parks and Recreation.

## PROJECT AGREEMENT

Project Title Marsh Park Development Project Number 73-0590

1. Nature of Agreement. This instrument, in 9 pages, of which this is the first, is intended to set out the terms and conditions, not otherwise appearing in statutes or regulations, of a grant of money from the Outdoor Recreation Account of the General Fund of the State of Washington to a state agency or local public body, herein called the Contracting Party, in aid of an outdoor recreation project. The state agency administering the grant is the Interagency Committee for Outdoor Recreation, herein called the Interagency Committee.
