A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING ISSUANCE OF AN UNCLASSIFIED USE PERMIT AS APPLIED FOR IN DEPARTMENT OF COMMUNITY DEVELOPMENT FILE NO. UUP-74-9 (P) BY ROBERT DAVIS TO AMEND A FORMER UNCLASSIFIED USE PERMIT APPLICATION AS FOUND IN DEPARTMENT OF COMMUNITY DEVELOPMENT FILE NO. UUP-CPA-73-7 (P) TO ALLOW THE SALES OF VARIOUS OTHER TYPES OF RECREATIONAL EQUIPMENT IN ADDITION TO MOTOR HOMES WITHIN THE SOUTHWEST QUADRANT OF THE FREEWAY ZONE ESTABLISHED BY CHAPTER 23.31 OF THE KIRKLAND ZONING ORDINANCE FOR THE INTERCHANGE OF I-405 AND SR-908.

WHEREAS, the Kirkland Planning Commission, during their regular meeting of March 14, 1974, determined that if there is to be a change in an Unclassified Use, such change must be accomplished by a new Unclassified Use Permit application, and

WHEREAS, the Kirkland Department of Community Development has received an application for an Unclassified Use Permit filed by Robert Davis, owner or agent for the owner of the property, for the sales of various types of recreational equipment as stipulated in the Planning Commission Advisory Report in addition to the sales of motor homes as allowed in the former Unclassified Use Permit, and

WHEREAS, the application has been assigned for identification File Number UUP-74-9(P) and submitted to the Kirkland Planning Commission, who held public hearing thereon on May 9, 1974, and

WHEREAS, pursuant to City of Kirkland Resolution No. 2181 dealing with environmental policy and the State Environmental Policy Act, an Environmental Assessment has been submitted to the City, reviewed by the Responsible Official of the City of Kirkland, and a negative declaration reached, and

WHEREAS, the Kirkland Planning Commission after said public hearing and consideration of the recommendations of the Department of Community Development, and having available to it during said hearing the Environmental Assessment and negative declaration, did adopt certain Findings, Conclusions and Recommendations approving issuance of the Unclassified Use Permit,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The Unclassified Use Permit applied for by the above named applicant, being Unclassified Use Permit No. UUP-74-9(P), shall issue subject to the conditions as set forth in the Findings, Conclusions and Recommendations of the Kirkland Planning Commission Advisory Report dated May 9, 1974, as signed by the Chairman thereof and filed in said file, which Findings, Conclusions and Recommendations are by this reference adopted by the City of Kirkland City Council as though fully set forth herein.

- Section 2. A certified copy of this resolution, together with the Findings, Conclusions and Recommendations therein adopted, shall attach to and become a part of the Unclassified Use Permit or evidence thereof delivered to the permittee.
- Section 3. Failure on the part of the holder of the Unclassified Use Permit to initially meet or maintain strict compliance with said standards and conditions shall be grounds for revokation in accordance with Section 23.30.100 of Ordinance No. 2183, the Kirkland Zoning Code.
- Section 4. Certified or conformed copies of this resolution shall be delivered or filed with the following:

 - b. Department of Community Development
 - c. Kirkland Building Official
 - d. Department of Public Services for the City of Kirkland
 - e. Department of Fire Services for the City of Kirkland
