

RESOLUTION NO. R-2260

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE PLANS, SPECIFICATIONS AND PROSPECTUS FOR THE URBAN ARTERIAL STREET IMPROVEMENT OF STATE STREET AND THIRD STREET FROM SECOND AVENUE SOUTH TO CENTRAL WAY, INCLUDING RECONSTRUCTION AND REALIGNMENT OF THE INTERSECTION OF THIRD STREET AND STATE STREET WITH KIRKLAND AVENUE, AUTHORIZING AND DIRECTING THE MAYOR TO SIGN THE PROSPECTUS, DECLARING THE PROJECT IS READY FOR THE CALLING OF BIDS, AND AUTHORIZING SAME.

WHEREAS, the City of Kirkland has heretofore authorized the preparation of plans and specifications for urban arterial street improvements to portions of State Street and Third Street from Second Avenue South to Central Way, including reconstruction and realignment of the intersection of Third Street and State Street with Kirkland Avenue, and

WHEREAS, the City is applying for financial assistance for said project by way of an Urban Arterial Board grant, and

WHEREAS, said proposed urban arterial street improvement is included within the Six Year Urban Arterial Street program as appears on Exhibit B, Section 19.08.050, Kirkland Municipal Code (Ordinance No. 2168), and

WHEREAS, the consulting engineers for the City of Kirkland for said project, Hart, Williams & Roth, Inc., have completed or substantially completed all plans, specifications and prospectus for said project, and the calling of bids therefor is now in order, and

WHEREAS, pursuant to City of Kirkland Resolution No. 2181 concerning environmental policy and the State Environmental Policy Act a public hearing was held for the purpose of obtaining public input and comment in regard to environmental aspects of said project, and thereafter an environmental assessment was prepared, submitted to the City, reviewed by the responsible official of the City of Kirkland, and a negative declaration reached, and

WHEREAS, said environmental assessment and declaration have been available and accompanied the proposed action through the entire review and consideration process by the City of Kirkland,


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:




Section 1. The Mayor of the City of Kirkland is hereby authorized and directed to sign on behalf of the City the prospectus for urban arterial street improvement project for improvement of State Street and Third Street from Second Avenue South to Central Way, including reconstruction and realignment of the intersection of Third Street and State Street with Kirkland Avenue, all within the City of Kirkland.

Section 2. The design, plans and specifications for said project as prepared for the City by its consulting engineers for said project, to-wit, Hart, Williams & Roth, Inc., have progressed toward completion to a point where authorization for the calling of bids is appropriate, and such authorization is hereby given.
