

RESOLUTION NO. R-2278

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE MAYOR TO SIGN A MEMORANDUM OF AGREEMENT WITH PUGET SOUND POWER AND LIGHT COMPANY FOR INSTALLATION OF SODIUM VAPOR STREET LIGHTING ON CENTRAL WAY, LAKE STREET AND KIRKLAND AVENUE, KIRKLAND, WASHINGTON, IN CONNECTION WITH A CONVERSION FROM OVERHEAD TO UNDERGROUND POWER.


WHEREAS, it is in the public interest and benefit to complete conversion from overhead to underground electrical power facilities by installation of an underground electrical system within the rights-of-way of Central Way, Lake Street and Kirkland Avenue within the City of Kirkland Central Business District to generally complete the downtown area underground lighting system and to tie together the lighting included as a part of LID No. 104 and LID No. 108, and

WHEREAS, the City is authorized to contract with Puget Sound Power and Light Company to perform such conversion work,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland, as follows:

Section 1. The mayor of the City of Kirkland is hereby authorized and directed to sign on behalf of the City of Kirkland that certain Memorandum of Agreement for installation of sodium vapor street lighting on Central Way, Lake Street and Kirkland Avenue, Kirkland, Washington in connection with a conversion from overhead to underground power, a copy of which, together with the plans and specifications for work to be performed, are attached to the original of this Resolution, or on file in the office of the Director of Public Services for the City of Kirkland.



MEMORANDUM OF AGREEMENT

FOR INSTALLATION OF SODIUM VAPOR STREET LIGHTING ON CENTRAL WAY,
LAKE STREET & KIRKLAND AVENUE, KIRKLAND, WASHINGTON, IN CONNECTION
WITH A CONVERSION FROM OVERHEAD TO UNDERGROUND POWER.

THIS AGREEMENT, made and entered into this day by and
between Puget Sound Power & Light Company, a Washington Corpor-
ation hereinafter called "Puget" and the City of Kirkland, a
Municipal Corporation, hereinafter called "City",

WITNESSETH:

1. Puget shall do all work and furnish all labor and
materials for installation, replacement and relocation of a
sodium vapor street lighting system consisting of 18 light
standards, anchor bases, luminaires, circuit wire and conduit
as an underground system within the rights-of-way of Central
Way, Lake Street and Kirkland Avenue within the City of Kirkland
Central Business District to generally complete the downtown
area underground lighting system and to tie together the lighting
included as a part of LID No. 104 and LID No. 108, all in
accordance with the plans and specifications attached hereto
and by this reference incorporated herein.

2. Puget shall commence work under this agreement five
days after receipt of notice to proceed received from the City
and shall complete the project within 90 days. Upon
completion, the street lighting system shall belong to the City
and the City shall pay to Puget the sum of \$29,314. The annual
maintenance rate to be paid by the City to Puget pursuant to

Puget's Tariff Schedule No. 51 shall be the appropriate schedule for customer owned lighting system.

3. Puget agrees to defend, save and hold harmless City as to any and all claims, real or imaginary, which may be made or asserted against the City for injury or damage to third persons as a result of the work required to be performed by Puget under paragraph 1 above.
