

RESOLUTION NO. R- 2284

A RESOLUTION OF THE KIRKLAND CITY COUNCIL AUTHORIZING AND DIRECTING THE MAYOR TO SIGN ON BEHALF OF THE CITY OF KIRKLAND, AN AGREEMENT WITH KING COUNTY AS A GOVERNMENTAL PARTICIPANT IN THE KING COUNTY APPLICATION FOR FUNDS PURSUANT TO THE COMMUNITY DEVELOPMENT ACT OF 1974 AND APPROVING THE ONE YEAR AND THREE YEAR COMMUNITY DEVELOPMENT PLANS REQUIRED BY SAID ACT.

WHEREAS, the federal government through adoption and administration of the Housing and Community Development Act of 1974 hereinafter referred to as "The Act" will make funds available to King County and local jurisdictions for expenditures during the calendar year 1975, and

WHEREAS, the Act allows joint participation of units of general government and the distribution of some or all of these funds to such governmental units, and

WHEREAS, the King County Council, by motion No. 1808, has determined that the amount of federal funds brought to the county by a jurisdiction's population characteristic will be allocated directly to that jurisdiction if a cooperation agreement is executed and the amount based on poverty and over-crowding be allocated among participating jurisdictions based on common needs, and

WHEREAS, a Department of Housing and Urban Development letter to King County dated November 27, 1974 states in part:

". . .in Fiscal Year 1974, the cooperation agreements, which must be submitted to the Department of Housing and Urban Development by January 17, 1975, need contain only a general committment between the County and the unit of general local government for the undertaking or assistance in undertaking of the essential community development and housing assistance activities to be identified and formulated in the plan and program.", and

WHEREAS, the Kirkland Planning Commission during a special meeting held December 19, 1974, did recommend and forward to the Kirkland City Council for its consideration and approval, the three year and one year community development plans, together with an environmental assessment of said plans, all as required by said Act, and

WHEREAS, the Housing Assistance Plan will be primarily developed by King County and delivered to the local jurisdictions for their approval prior to the application being submitted to the Department of Housing and Urban Development, and

WHEREAS, King County will undertake block grant funding activities with Kirkland as specified in the plan only by granting funds to Kirkland for their execution, and

WHEREAS, Kirkland's three year and one year community development plans are required to be revised annually and resubmitted to King County as a part of an annual application, should the City of Kirkland wish to continue with the joint application process with King County,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland, as follows:

Section 1. The Kirkland City Council hereby approves, after consideration and review of the environmental assessment submitted, the three year Community Development Plan and the one year Community Development Plan as recommended by the Kirkland Planning Commission, and authorizes said plans, together with the environmental assessment thereof to be sent to King County for inclusion in the Community Development Act of 1974 joint application to the Department of Housing and Urban Development.

Section 2. The Mayor of the City of Kirkland is hereby authorized and directed to sign on behalf of the City an agreement with King County to submit a joint application with King County to the Department of Housing and Urban Development for funds available pursuant to the Community Development Act of 1974.

Section 3. Pursuant to the Community Development Act of 1974, the liaison officer for the City of Kirkland is hereby designated as Allen B. Locke, City Manager.

Section 4. The Kirkland City Council reserves to the City of Kirkland the right to withdraw from joint application with King County during the fiscal year 1976. Such withdrawal to be accomplished by resolution of the City Council timely adopted.

PASSED by a majority vote of the Kirkland City Council in special meeting duly and properly called in the manner prescribed by the laws of the State of Washington and the Ordinances of the City of Kirkland and held on the 20th day of December, 1974.
