

RESOLUTION NO. R 2301

A RESOLUTION OF THE KIRKLAND CITY COUNCIL DECLARING THE NEED FOR A STUDY BY SKILLED CONSULTANTS OF THE TOTEM LAKE - PAR MAC - UPPER JUANITA BAY VALLEY AREA OF THE CITY AND CREATING A CITIZENS ADVISORY COMMITTEE TO ASSIST IN THE CONDUCT OF SUCH STUDY.

WHEREAS, the area of Kirkland generally referred to as the Totem Lake - Par Mac - upper Juanita Bay Valley area has environmental and social, as well as economic and industrial significance, and

WHEREAS, development of land use policies, goals and regulations for present and future development within said area require identification and study of many interrelated factors, including economic, marketing, industrial, social, environmental, urban design and circulation, and

WHEREAS, there presently exists a possibility of certain economic planning and development funding assistance, and

WHEREAS, the City Council deems it to be in the best interests of the City and its residents, including the property owners and business operators within the Totem Lake - Par Mac - upper Juanita Bay Valley area to hire skilled consultants to perform or assist in the performance of a study of said area for use in the preparation of the City's comprehensive land use and development policy plan and any present and future development within said area, and

WHEREAS, the City Council finds that a citizens advisory committee will be of immediate assistance to the City Council and City Administration,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. There is hereby created an industrial park and development citizens advisory committee to be composed of property owners and business operators from within the Totem Lake - Par Mac - upper Juanita Bay Valley area of the City, together with other qualified and interested members of the general public. Said citizens advisory committee shall perform the consultation, liaison and advisory functions


assigned to it by the City Council and may make such comments and recommendations and provide such other and further assistance to the City Council, the City Administration and any hereafter hired consultants as may be appropriate.

The Mayor has recommended and the City Council hereby confirms appointment of the following to be the initial members of said citizens advisory committee:


