

RESOLUTION NO. R - 2304

A RESOLUTION OF THE KIRKLAND CITY COUNCIL RELATING TO MISCELLANEOUS GRANTS TO THE CITY OF KIRKLAND UNDER THE 1973 FEDERAL HIGHWAY SAFETY ACT, ACCEPTING SAID GRANTS AND AUTHORIZING THE CITY MANAGER OR HIS DELEGATE TO SIGN ON BEHALF OF THE CITY OF KIRKLAND ALL REQUIRED DOCUMENTS RELATING THERETO.

WHEREAS the City of Kirkland has been notified of its receipt of several grants made pursuant to the 1973 Federal Highway Safety Act, and

WHEREAS it is necessary and required for the City Council to accept same and to authorize the City Manager or the Director of Public Services, as the delegate of the City Manager, to sign on behalf of the City of Kirkland, the various required documents relating to said grants,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1: The Kirkland City Council does hereby accept, on behalf of the City of Kirkland, the following specific grants awarded to the City pursuant to the 1973 Federal Highway Safety Act:

- (a) Under Section 203 Minor Project No. RRS-1555(4): Funds for improvement of the N.E. 124th railroad crossing, \$330.00. Federal aid supplies 90%, or \$290.00, local Agency supplies \$40.00.
- (b) Section 205 Grant Project No. PMS-000S(10) providing funds for striping and button improvements at spot locations: Two separate grants of \$52,100.00 and \$24,600.00, or a total of \$76,700.00. Federal aid supplies 100%, or \$76,700.00.
- (c) Under Section 209, High Hazard Location: Funds for improvements at the intersection of Lake Street and Kirkland Avenue, \$4,500.00. Federal aid supplies 90%, or \$4,050.00, Agency supplies \$450.00.
- (d) Under Section 230, Project No. SRS-000S(16): Funds for improvement of railroad crossings at five locations. Grant award \$2,160.00. Federal aid supplies 90%, or \$1,900.00, the Agency supplies \$260.00.

Section 2: The Kirkland City Manager, or the Director of Public Services as his delegate, is hereby authorized and directed to sign on behalf of the City of Kirkland any and all necessary or required documents relating to the grant awards identified and accepted in Section 1 of this resolution.
