

RESOLUTION NO. R- 2380

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND CONSENTING TO THE TRANSFER OR ASSIGNMENT OF THE SECOND AVENUE SOUTH STREET END USE PERMIT FROM THE PRESENT HOLDER THEREOF, MOSS BAY MARINA JOINT VENTURE, TO MOSS BAY ASSOCIATES, A WASHINGTON LIMITED PARTNERSHIP.

WHEREAS, pursuant to Resolution No. R-2273 the City of Kirkland issued to C. S. Hadley, Sr. a Street End Use Permit as to a portion of the Second Avenue South Street End which permit was, on November 7, 1974, recorded in the King County Department of Elections and Records under their filing and receiving No. 7411070627, and which permit was thereafter, pursuant to Resolution No. R-2293, transferred or assigned to Moss Bay Marina Joint Venture, and

WHEREAS, said Street End Use Permit was thereafter, pursuant to Resolution No. R-2375 adopted by the Kirkland City Council on June 21, 1976, amended as to its term and certain other conditions, and

WHEREAS, said Street End Use Permit by its terms may not be transferred or assigned by the permittee without the consent of the City of Kirkland expressed by City Council Resolution, and

WHEREAS, Moss Bay Marina Joint Venture, as current permittee, and Moss Bay Associates, a Washington Limited Partnership, as proposed transferee or assignee, have requested such consent to transfer from the City, and

WHEREAS, said transferee or assignee appears to be the actual legal entity or party in interest who will be responsible for construction, operation, and maintenance of the improvements within said street end authorized by the Street End Use Permit, and

WHEREAS, such transfer or assignment therefor appears to be in the public interest,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The City Council of the City of Kirkland does hereby consent to the transfer or assignment from Moss Bay Marina Joint Venture to Moss Bay Associates, a Washington Limited Partnership, of the Second Avenue South Street End Use Permit issued by the City pursuant to Resolution No. R-2273, assigned to Moss Bay Marina, a joint venture, pursuant to Resolution NO. R-2293, and amended as to term and other conditions pursuant to Resolution No. R-2375, which permit was originally recorded on November 7, 1974, with the King County Department of Elections and Records under their filing and receiving No. 7411070627. Provided, however, that said consent is conditioned upon the following:


A. The transfer or assignment of said Street End Use Permit shall not, as between the City of Kirkland and C. S. Hadley, Sr., original permittee, and participants in Moss Bay Marina Joint Venture, present holder of said permit, operate to relieve either the original permittee or the present holder of said permit of any duty, obligation or liability imposed by the terms and conditions of said Street End Use Permit, as amended, upon the original permittee and present holder of said permit, and

B. The transfer or assignment shall be in writing in a form acceptable for recording by the King County Department of Elections and Records and shall be so recorded. A copy of said transfer or assignment agreement, including recorder's receipt or file number, shall be filed with the City of Kirkland, and

C. Said transfer or assignment agreement shall provide that the transferee or assignee shall perform and be bound by all of the terms and conditions of said Street End Use Permit, and

D. In the event the transferee at any time during the life of the permit may enter into a management contract or other agreement with any third party for the operation or management of the improvements within the End Street Permit area, a copy of such agreement shall be filed with the City Clerk for the City of Kirkland.
