

RESOLUTION NO. R 2393

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING AND APPROVING AN AMENDMENT TO THE EXISTING CONTRACT WITH BAYSIDE DISPOSAL COMPANY TO PROVIDE FOR AN INCREASE IN THE AMOUNT PAYABLE TO SAID CONTRACTOR FOR A SINGLE FAMILY RESIDENTIAL TOTAL PICKUP.

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

WHEREAS the parties hereto on June 29, 1973, entered into a five year contract for the collection and disposal of garbage and refuse in the City of Kirkland including mandatory total pickup of all single family residential garbage placed for collection, and

WHEREAS said contract provided "that the amounts bid within Alternate III-1 residential (single family mandatory total pickup) may be subject to review and modification at the end of the third year:, and


WHEREAS contractor has requested such a review and modification citing increased costs of operation including labor cost and county dump fees, and

WHEREAS it appear that an increase is justified,


NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND, as follows:

Section 1: The Mayor is hereby authorized and directed to sign on behalf of the City of Kirkland that certain Amendment of Contractor between the City of Kirkland and Bayside Waste Hauling and Transfer Company, Inc., d/b/a Bayside Disposal Company, providing for an increase in payment to the contractor for single family residential total service pickup from \$2.14 per month per residential customer to \$2.60 per month per residential customer to be effective October 1, 1976. A copy of said Amendment is attached to the original of this resolution and by this reference incorporated herein.

ADOPTED by majority vote of the Kirkland City Council in regular meeting on the 20th day of September, 1976.

AMENDMENT TO CONTRACT FOR GARBAGE COLLECTION SERVICES BETWEEN THE CITY OF KIRKLAND, THEREIN CALLED "CITY" and BAYSIDE WASTE HAULING AND TRANSFER COMPANY, d/b/a BAYSIDE DISPOSAL COMPANY AS "CONTRACTOR" AND ENTERED INTO BETWEEN THE PARTIES ON JUNE 29, 1973.

WHEREAS the parties hereto on June 29, 1973, entered into a five year contract for the collection and disposal of garbage and refuse in the City of Kirkland including mandatory total pickup of all single family residential garbage placed for collection, and

WHEREAS said contract provided "that the amounts bid within Alternate III-1 residential (single family mandatory total pickup) may be subject to review and modification at the end of the third year", and

WHEREAS contractor has requested such a review and modification citing increased costs of operation including labor cost and county dump fees, and

WHEREAS it appears that an increase is justified,
NOW THEREFORE, IT IS AGREED BY AND BETWEEN THE PARTIES as follows:

1. The rate to be paid by the City to the Contractor for complete collection and disposal of all refuse, garbage and litter (total service) under Alternate III-1(a) shall be increased from the existing rate of \$2.14 per month per residential customer to \$2.60 per month per residential customer.

2. All other provisions of said contract shall remain

in full force and effect and binding upon both the parties
for the life of the contract.

3. The amended rate herein provided for shall become
effective as of October 1, 1976.
