A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND RELATING TO AREAWIDE AND SUBREGIONAL COOPERATIVE PLANNING AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO SIGN ON BEHALF OF THE CITY OF KIRKLAND CONTRACTS AND OTHER DOCUMENTS BETWEEN THE CITY AND PUGET SOUND COUNCIL OF GOVERNMENTS AND KING COUNTY, PROVIDING FOR COOPERATIVE SUBREGIONAL PLANNING AND POLICY FORMULATION, FINANCIAL ASSISTANCE AND PARTICIPATION THEREIN, AND SCOPE OF PLANNING SERVICES TO BE PERFORMED OR PROVIDED BY THE CITY OF KIRKLAND.

WHEREAS, sound and accepted areawide land use policy requires the full and cooperative involvement and cooperation of the Puget Sound Council of Governments, its King County subregion, and local governments including King County and the City of Kirkland, and

WHEREAS, certain financial assistance is available from King County and the Puget Sound Council of Governments to assist the City of Kirkland in participating in such areawide land use policy and development and planning efforts, and

WHEREAS, it is essential to the land use policies of the City of Kirkland that Kirkland participate in such areawide and subregional planning efforts,

NOW, THEREFORE, the City Council of the City of Kirkland do hereby resolve:

Section 1: The City of Kirkland should coopératively and actively participate in the areawide land use policy development and planning under the proposals of King County and the Puget Sound Council of Governments (and its King County subregional council).

Section 2: The City Manager of the City of Kirkland is hereby authorized and directed to sign on behalf of the City of Kirkland any and all contracts, agreements and other documents to be entered into between the City of Kirkland and King

County or the Puget Sound Council of Governments (including its King County subregional council) for receipt of financial assistance and for areawide planning participation consistent with this resolution the proposal made to the City of Kirkland by the Puget Sound Council of Governments in regard to services to be rendered by the City (copy of which is attached to the original of this resolution as Exhibit B) and Motion No. 03003 of the King County Council relating to building and planning financial assistance for local communities (copy of which is attached to the original of this resolution as Exhibit A).

A MOTION establishing a Local Capacity Building/Planning Assistance Program for

WHEREAS, sound and accepted areawide land use policy requires the full involvement and cooperation of suburban cities and towns in the development of said policy; and

the suburban cities and towns of King County.

WHEREAS, often due to a lack of resources, suburban cities and towns find it impossible to participate effectively in the development of areawide policy by PSCOG and Metro; and

WHEREAS, full participation by suburban cities and towns in areawide policy development is particularly critical in 1977 and 1978 during the formation of the Subregional Land Use Plan scheduled for completion in April, 1978; and

WHEREAS, recognizing this immediate need for additional resources, the King County Council established \$66,000 in the 1977 County Budget to help suburban cities and towns develop the capacity to participate in areawide policy formulation; and

WHEREAS, an additional \$5,000 has been authorized by Motion No. 77-216 for Des Moines and Normandy Park; and

WHEREAS, an additional \$42,800 is necessary to meet the request of the Green River Valley cities for local planning support.

NOW THEREFORE, BE IT MOVED by the Council of King County:

- 1. A local capacity building/planning assistance program is hereby established to enable the suburban cities and towns to participate with King County in the development of areawide land use policy as a part of the formulation of the Subregional Land Use Plan.
- 2. The attached allocation criteria are hereby adopted as the basis for committing County funds and based on these criteria, the County Executive is authorized to allocate the funds established in the 1977 Budget as follows:

CRITERIA FOR ALLOCATING LOCAL PLANNING ASSISTANCE FUNDS

FIRST CLASS CITIES (except Seattle) Over 20,000 population

- 1. County funding on a population basis, \$.50/person
- 2. Local 25% of County Contribution with 1 in cash

SECOND CLASS CITIES Over 10,000 population

- 1. County funding on a population basis, \$1.00/person
- 2. Local same as first class cities

THIRD CLASS CITIES Over 1,500 population



County - CETA position

- Local Commitment to absorb function if the jurisdiction decides to continue activity
- 3. Exception When two or more adjacent third class cities join together and combined population exceeds 10,000 then qualify for second class city funding.

FOURTH CLASS TOWNS

1. County - Small town planning assistance from the County.

Appendix B

SCOPE OF SERVICES CONTRACT BETWEEN

THE PUGET SOUND COUNCIL OF GOVERNMENTS

AND

THE CITY OF KIRKLAND, WASHINGTON

The City of Kirkland will provide the following as part of this contract:

- 1. Data as may be required in the development of the Growth and Development plan.
- 2. Liaison and staff assistance to the regional in the development of work programs, studies and other components of a subregional plan so much as it affects their jurisdictions and their attendant planning areas.
- 3. Staff time to attend meetings, conferences and provide personal contacts to the Subregional Council and to King County in the preparation of the Growth and Development Plan.
- 4. Written comments and provide for local comment and input as required to the Subregional planning staff and to King County as appropriate to the development plan as it applies to their jurisdiction and to their planning areas.

Staff participation in addressing issues common to jurisdictions such as Metro, King County and others as appropriate with special attention to land use issues, water quality and supply, transportation and Metropolitan Planning Organization (MPO) work activity.
