## RESOLUTION NO. R-2445

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING AND DIRECTING THE CITY ADMINISTRATION TO APPLY TO THE WASHINGTON STATE DEPARTMENT OF HIGHWAYS FOR FEDERAL AID PROJECT FUNDING ASSISTANCE FOR TRAFFIC CONTROL SIGNALIZATION AT THE INTERSECTIONS OF STATE ROUTE 908 AND SIXTH STREET, AND KINGSGATE WAY AND 120TH AVENUE N.E., AND STATE ROUTE 908 AND 114TH AVENUE N.E., ALL WITHIN THE CITY OF KIRKLAND, AND AUTHORIZING THE CITY MANAGER OR THE DIRECTOR OF PUBLIC SERVICES, AS HIS DELEGATE, TO SIGN ANY AND ALL DOCUMENTS IN RELATION THERETO.

WHEREAS, the cost of traffic control signalization for the intersection of State Route 908 (Central Way) and Sixth Street is estimated to cost \$94,100.00, and

WHEREAS, the cost of traffic control signalization of the intersection of Kingsgate Way and 120th Avenue N.E. is estimated to cost \$75,650.00, and

WHEREAS, the cost of traffic control signalization of the intersection of State Route 908 (Central Way) and 114th Avenue N.E. is estimated to cost \$90,650.00, and

WHEREAS, there is federal aid funding available to assist in the construction and installation of said traffic control signalization, and

WHEREAS, the Washington State Department of Highways has been designated to fulfill the responsibilities of the federal government in the administration of such funding projects, now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND as follows:

Section 1. The City administration is hereby authorized and directed to apply for federal funding assistance through the Washington State Department of Highways to assist in the construction and installation of traffic control signalization at the intersection of SR 908 (Central Way) and Sixth Street, and the intersection of Kingsgate Way and 1120th Avenue N.E., and the intersection of SR 908 (Central Way) and 114th Avenue N.E., all within the City of Kirkland.

Section 2. The City Manager or the Director of Public Services, as his delegate, of the City of Kirkland is hereby authorized and directed to sign on behalf of the City of Kirkland any and all documents necessary or required to apply for and obtain such funding assistance

including project prospectus, fund or grant applications, and contracts therefor between the City of Kirkland and the Washington State Department of Highways and/or the federal Government.
