

RESOLUTION NO. R - 2470

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND GRANTING A SIX MONTH EXTENSION TO THE APPLICANT IN DEPARTMENT OF COMMUNITY DEVELOPMENT FILE NO. R-CUP-77-9(P) AND EXTENDING THE TIME WITHIN WHICH SAID APPLICANT MAY MEET THE CONDITIONS IMPOSED BY RESOLUTION OF INTENT TO RECLASSIFY CONDITIONAL USE PERMIT BEING RESOLUTION NO. R-2425 AND AMENDING SECTION 2 OF RESOLUTION NO. R-2425.

WHEREAS, Sec. 23.62.120 of Ordinance No. 2183 requires that the applicant for a rezone of property pursuant to the Resolution of Intent to Reclassify Procedure shall obtain a building permit for his proposed development within six months from the date of the adoption of the resolution of intent to reclassify, unless the City Council grants a six month extension upon the recommendation of the Planning Commission, and

WHEREAS, Resolution No. R-2425 titled "A Resolution of the City Council of the City of Kirkland Approving the Issuance of an Intent to Rezone Permit and Conditional Use Permit as Applied for in the Department of Community Development File No. R-CUP-77-9(P) by Totem Shopping Center Association to construct a professional Office building and restaurant being within an RM 900 Zone and Setting Forth Conditions to which such an Intent to Rezone Permit and Conditional Use Permit shall be subject," was adopted by the Kirkland City Council in regular meeting on March 21, 1977, and

WHEREAS, Totem Shopping Center Association has submitted to the Kirkland Planning Commission a written request for an extension of the time limitation for a period of six months to March 19, 1978, and

WHEREAS, the Kirkland Planning Commission has considered said application for time extension and has recommended the approval of same to the Kirkland City Council,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1: Section 2 of Resolution No. R-2425 be and hereby is amended to read as follows:

Section 2. The Resolution of Intent to Rezone Permit shall be issued to the applicants subject to the conditions set forth in the findings, conclusions and recommendations as hereinabove adopted by the City Council. The City Council further approves in principle the request for reclassification from RM 900 to PR and pursuant to Chapter 23.62 of Ordinance No. 2183 the Council shall by ordinance effect such reclassification upon being advised that all of the conditions, stipulations, limitations, and requirements contained in this resolution, including those adopted by reference, have been met by March 19, 1978. Pursuant to Section 23.62.120 of Ordinance No. 2183, no further extension of time beyond March 19, 1978, shall be authorized.

Section 2. A certified copy of this amendatory resolution shall be delivered to the applicant of record in the Department of Community Development file No. R-CUP-77-9(P) and conformed copy shall be delivered to the following:
