RESOLUTION NO. R-2501

A RESOLUTION OF THE CITY COUNCIL OF THE CITY KIRKLAND AUTHORIZING THE MAYOR TO SIGN ON BEHALF OF THE CITY AN EASEMENT OVER A PORTION OF THE NORTHERLY FIFTEEN FEET OF THAT PORTION OF WAVERLY PARK LYING ADJACENT TO AND FIFTEEN FEET EAST OF WAVERLY PARK WAY AS ESTABLISHED BY RESOLUTION NO. 539.

WHEREAS, the owner of real property adjoining Waverly Park along the north boundary of said park has requested the City to provide improved access to said real property, either by easement grant or by widening of Waverly Park Way (as established in Resolution No. 539), adopted by the Kirkland City Council on November 15, 1965), and

WHEREAS, the Park Department and the Park Board have recommended to the city Council the granting of an easement for such ingress and egress, subject to certain conditions, all as set forth in the memorandum from the Director of Parks and Recreation dated January 25, 1978, now, therefore,

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The Kirkland City Council approves the grant of an easement for ingress and egress to the property abutting upon the north boundary line of Waverly Park provided that the owner of said property fulfill all of the conditions recommended by the Park Department and the Park Board as set forth in the memorandum dated January 25, 1978, from David Brink, Director of Parks and Recreation for the City of Kirkland. A copy of said memorandum is attached to the original of this Resolution, and by this reference incorporated herein.

Section 2. The Mayor and Director of Administration and Finance for the City of Kirkland are hereby authorized and directed to sign on behalf of the City of Kirkland an easement in the form attached to the original of this Resolution, and by this reference incorporated herein. Said easement shall be delivered to the grantee by the City Manager only upon written certification to the City Manager from the Director of Parks and Recreation that all of the conditions herein

incorporated by reference have been fulfilled, or bond for their performance has been received by the City.

Commencing at a point on the east right-of-way line of Waverly Park Way as established by City of Kirkland Resolution No. 539, thence northerly along said easterly right-of-way line of Waverly Park Way fifteen feet to the northerly boundary of Waverly Park, thence easterly along the northerly boundary of Waverly Park a distance of fifteen feet, thence southwesterly to the point of beginning.

This easement is granted solely for the use and benefit of Lots 1 and 2 of that certain informal subdivision approved November 17, 1965, by the City of Kirkland pursuant to Kirkland Ordinance No. 997. Said easement shall run with the land.

Gaw request for easement

Re Mr. Gaw's request for a 15' easement across the north-east corner of Waverly Park: The Park Board approved his request at their January meeting to be submitted to the City Council with the following conditions as recommended by staff:

- 1. Clean-up of the existing condition which has a broken fence between the City park and debris placed upon city property from the retaining wall project.
- 2. Erection of a retaining wall backed with quarry spall, and drain pipe on the easement to preclude a slide which is likely to occur with removal of the alder tree. Design to be approved by the City of Kirkland.
- 3. Asphalting of easement section to match grade with park parking lot. Grade approval by Park Director.
- 4. Survey to determine property line.
- 5. All costs to be borne by applicant.
- 6. Final design and installation approval by Park Director.
- Approval by City Council.
- 8. A performance bond should be secured by Mr. Gaw and a "hold narmless" agreement should be signed by him.

Mr. Gaw's original request was submitted to the City Council. The foregoing approved by Mr. Thomas and the Development Review Committee.
