A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND GRANTING A SIX MONTH EXTENSION TO THE APPLICANT IN DEPARTMENT OF COMMUNITY DEVELOPMENT FILE NO. CUP-77-63(P) AND EXTENDING THE TIME WITHIN WHICH SAID APPLICANT MAY MEET THE CONDITIONS IMPOSED BY RESOLUTION R-2462 PERTAINING TO THE CONDITIONAL USE PERMIT FOR THE SUBJECT PROPERTY.

WHEREAS, Section 23.56.090 of Ordinance No. 2183 requires that the applicant for Conditional Use Permit shall obtain a Building Permit for the proposed development within six months of the date of the adoption of the Resolution, unless the City Council grants a six month extension upon the recommendation of the Planning Commission, and

WHEREAS, Resolution No. 2462 entitled "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE ISSUANCE OF A CONDITIONAL USE PERMIT AS APPLIED FOR IN DEPARTMENT OF COMMUNITY DEVELOPMENT FILE NO. CUP-77-63(P) BY BUD BUSHNELL, GENIE INDUSTRIES, INC., TO CONSTRUCT ONE WAREHOUSE/INDUSTRIAL TYPE BUILDING, BEING WITH A PLANNED AREA 6B ZONE, AND SETTING FORTH CONDITIONS TO WHICH SUCH CONDITIONAL USE PERMIT SHALL BE SUBJECT." was adopted by the Kirkland City Council in regular meeting on October 3, 1977, and

WHEREAS, Mr. Bushnell, has submitted to the Kirkland Planning Commission a written request for an extension of the time limitation for a period of six months to October 3, 1978, and

WHEREAS, the Kirkland Planning Commission has considered said application for time extension and has recommended the approval of same to the Kirkland City Council,

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Kirkland as follows:

Section 1: Section 1 Resolution R-2462 shall be and hereby is amended to read as follows:

"Section 1. The Findings, Conclusions, and Recommendations of the Kirkland Planning Commission as signed by the Chairperson thereof and filed in the Department of Community Development File No. CUP-77-63(P) are adopted by the Kirkland City Council as though fully set forth herein. Furthermore, these conditions shall be met by October 3, 1978. Pursuant to Section 23.56.090 of Ordinance No. 0-2183, no further extension of time beyond October 3, 1978, shall be authorized."

Section 2. A certified copy of this resolution, together with the Findings, Conclusions and Recommendations therein adopted shall be attached to and become a part of the Conditional Use Permit or evidence thereof delivered to the permittee.
