

RESOLUTION NO. 2516

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AMENDING SECTION 2 OF RESOLUTION NO. R 2478 RELATING TO THE ESTABLISHMENT OF PRIORITIES AS TO AMOUNTS AND FUND SOURCES FOR CERTAIN INDIVIDUAL PROGRAMS APPROVED AS A PART OF THE JULY, 1978, THROUGH JULY, 1979, ONE-YEAR HOUSING AND COMMUNITY DEVELOPMENT PROGRAM, ALL AS PROVIDED FOR BY SAID RESOLUTION NO. R 2478.

WHEREAS, the City of Kirkland, by Resolution No. 2478, adopted December 5, 1977, established priorities as to amount and source of funding (i.e., needs funding or population funding) for individual programs to be carried out as a part of the one-year Housing and Community Development Program for the period July, 1978, through June, 1979, and

WHEREAS, a portion of said Resolution No. 2478 provided:

"That the City Council upon review following allocation by King County of available needs funds, may exclude any individual programs listed above as having a need source of funding,"

and

WHEREAS, the City Council has now made such a review and has determined that certain "needs" funded programs should be excluded and Section 2 of Resolution No. R2478 should be amended to reflect such action of the City Council,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. Section 2 of Resolution No. R2478 adopted December 5, 1977, be and it hereby is amended to read as follows:

"Section 2: The one-year program plan herein approved and adopted consists of the following individual programs for which priority amount of funding and identification of funding source, i.e., population funds or needs funds, are as set forth below:

[provided, however, that the City Council, upon review following allocation by King County of available needs funds, may exclude any individual programs listed above as having a needs source of funding.]

The City administration is hereby authorized and directed to take all steps necessary or required including the signing of any and all documents or agreements which may be necessary in order to carry out the programs contained in the one-year Housing and Community Development Plan as herein amended.
