A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE CITY MANAGER TO SIGN ON BEHALF OF THE CITY OF KIRKLAND A CONTRACT PROVIDING FOR FUNDING BY KING COUNTY TO ASSIST IN UNDERWRITING THE EXPENSE OF THE JOINT CITY OF KIRKLAND/KING COUNTY RECREATION PROGRAM CARRIED ON BY THE CITY OF KIRKLAND WITHIN THE CITY OF KIRKLAND AND WITHIN THAT PORTION OF UNINCORPORATED KING COUNTY SURROUNDING THE CITY OF KIRKLAND.

WHEREAS, the City of Kirkland, in agreement with King County, has for the past several years, provided a joint recreation program for the City of Kirkland, that portion of unincorporated King County surrounding the City of Kirkland; and

WHEREAS, King County has agreed to increase its contribution towards the cost of said joint recreation program for the calendar year 1980 to an amount not to exceed \$16,000.00.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The City Manager is hereby authorized and directed to sign on behalf of the City of Kirkland that certain contract for services between the City of Kirkland and King County, wherein King County agrees to contribute an amount not to exceed \$16,000.00 toward the cost of the Kirkland King County Joint Recreation Program, to be conducted within the City of Kirkland and the unincorporated area of King County surrounding the City of Kirkland for the calendar year 1980 (a copy of said contract is attached to the original of this resolution as Exhibit A).
