RESOLUTION NO. R-2714

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND REDESIGNATING "RESTRICTED PARKING ZONES" WITHIN THE AREA ADJACENT TO THE INTERSECTION OF CENTRAL WAY AND MARKET STREET AND DIRECTING THE TRAFFIC ENGINEER, PURSUANT TO SECTION 12.44.090 OF THE KIRKLAND MUNICIPAL CODE, TO INSTALL PARKING RESTRICTION SIGNS IN ACCORDANCE HEREWITH.

WHEREAS, the City owned parcel of land, approximately 13,000 square feet in area, within the southeast quadrant of the intersection of Market Street and Central Way, has been made available as a boat trailer parking facility between the months of May and September; and

WHEREAS, said facility, which can accommodate six to eight boat trailers, could accommodate approximately 20 automobiles if converted to a public off-street parking facility exclusively; and

WHEREAS, a serious shortage of available off-street public parking exists within the Central Business District and the area adjacent to Marina Park; and

WHEREAS, it appears to the City Council that the use of said property as a full-time public off-street parking facility for automobiles throughout most days of the year would be the most efficient and appropriate use of said property in terms of public benefit; and

WHEREAS, there is, nevertheless, a necessity to provide some limited parking to be used for the purpose of securing boats to their trailers following removal of the boats from Lake Washington; and

WHEREAS, use of the lot for trailer parking during Sundays would not constitute a large use conflict.

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland as follows:

Section 1. Pursuant to the provisions of Section 12.44.080 of the Kirkland Municipal Code, the on-street parking area located within the east and west sides of the right-of-way of Market Street, south of Central Way, is hereby designated Restricted Parking Zone 14. Said area shall further, pursuant to Section 12.44.010(a)(2) Kirkland Municipal Code, be signed to permit the parking of vehicles with boat trailer attached for a period of not to exceed 20 minutes for the purpose of rigging and securing boat to trailer

Section 2. Pursuant to Section 12.44.080, the offstreet public parking facility, located within and adjacent to the southeast quadrant of Central Way and Market Street, is hereby designated Restricted Parking Zone 4 (3 hour parking). Pursuant to Section 12.44.100 Kirkland Municipal Code, the three hour parking restriction shall be in force and effect between the hours of 9:00 a.m. and 6:00 p.m. seven days a week (including legal holidays) provided however that between the months of April through September inclusive, said lot shall be designated Restricted Parking Zone 4 only for six (6) days per week, being Monday through Saturday. During these months, said lot shall be available for the exclusive use of boat trailer parking between the hours of 6:00 p.m. Saturday and 6:00 a.m. the following Monday.

Section 3. In accordance with the provisions of Section 12.44.060 Kirkland Municipal Code, the Chief of Police and the Traffic Engineer for the City of Kirkland are hereby directed to install signs and other traffic regulation marking devices to designate the parking restriction limitations established by this resolution.
