

RESOLUTION NO. R- 2814

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER, OR THE DIRECTOR OF THE DEPARTMENT OF PARKS AND RECREATION, AS HIS DELEGATE, TO MAKE APPLICATION FOR FUNDING ASSISTANCE FOR AN OUTDOOR RECREATION PROJECT TO THE INTERAGENCY COMMITTEE FOR OUTDOOR RECREATION AS PROVIDED BY THE MARINE RECREATION LAND ACT.

WHEREAS, the Land Use Policies Plan (Comprehensive Land Use Plan) for the City of Kirkland includes within its comprehensive park and recreation plan section, identification and designation of Peter Kirk Memorial Park as a community park located within the Central Business District, and

WHEREAS, under the provisions of the Marine Recreation Land Act, state and federal funding assistance has been authorized and made available to aid in financing the cost of construction to improve and redevelop outdoor recreational facilities of local public bodies, and

WHEREAS, the City of Kirkland has held and received public input and comment regarding the relationship of Peter Kirk Park to the Central Business District and the construction and redevelopment of Peter Kirk Park, an existing community park within the City of Kirkland Central Business district, and

WHEREAS, the City Council of the City of Kirkland considers it to be in the best public interest and necessary for the continued public welfare, health and safety to make certain necessary improvements, construction and redevelopment of Peter Kirk Park, consistent with the provisions of the Comprehensive Land Use Plan and the specific plan for improvement and redevelopment of Peter Kirk Park, now, therefore, be it

RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The City Manager, or the Director of the Department Parks and Recreation, as his delegate, is hereby authorized and directed to make formal application to the Interagency Committee for Outdoor Recreation for fund assistance.

Section 2. Any fund assistance, either federal or state, received as a result of such application shall be used solely for improvement, construction and redevelopment of Peter Kirk Park in accordance with said application.

Section 3. The City's matching share for the project will be derived from monies under the control of the City of Kirkland and designated to be used for parks and recreation improvements.

Section 4. Any property acquired with financial aid through the Interagency Committee for Outdoor Recreation will be placed in use as an outdoor recreation facility and will be retained in such use in



perpetuity unless as otherwise provided and agreed to by the City of Kirkland, the Interagency Committee for Outdoor Recreation, and any affected federal agency.


Section 5. This resolution shall become a part of any formal application made by the City of Kirkland for funding assistance in relation to Peter Kirk Park made to the Interagency Committee for Outdoor Recreation.
