

RESOLUTION NO. R -2834

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE DIRECTOR OF ADMINISTRATION AND FINANCE IN CONSULTATION WITH THE DIRECTOR OF PUBLIC SERVICE TO CANCEL CERTAIN UNPAID AND DELINQUENT WATER-SEWER-GARBAGE ACCOUNTS RECEIVABLE AS UNCOLLECTABLE.

Whereas, the Director of Administration and Finance has requested authority to cancel certain unpaid delinquent water-sewer-garbage accounts receivable as set forth in Appendix A to this resolution; and

Whereas, it appears that said accounts are uncollectable either because the building or structure to which the services were rendered no longer exist or because the statute of limitations may bar recovery; and

Whereas, sound business and accounting practices call for the cancellation of such uncollectable accounts; and


Whereas, the City Council finds that the Director of Administration and Finance should be granted authority to, in consultation with the Director of Public Services, cancel said accounts; now therefore

Be it Resolved by the City Council of the City of Kirkland as follows:


Section 1. The Director of Administration and Finance for the City of Kirkland in consultation with the Director of Public Services is hereby authorized to cancel as uncollectable those certain unpaid and delinquent water-sewer-garbage accounts receivable set forth in Appendix A to this resolution and by this reference incorporated herein.
