

RESOLUTION NO. R-2851

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE CITY MANAGER TO SIGN A WASHINGTON STATE DEPARTMENT OF TRANSPORTATION CITY/COUNTY AGREEMENT, DEALING WITH FEDERAL FUNDING FOR IMPROVEMENTS ON LAKEVIEW DRIVE BETWEEN SR-908 AND STATE STREET.

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The City Manager is hereby authorized to sign that certain Washington State Department of Transportation City/County Agreement, Supplement No.3, dealing with Federal funding for an improvement on Lakeview Drive between SR 908 to State Street. A copy of said agreement is attached to the original of this Resolution, and by this reference is fully incorporated herein.
