

RESOLUTION NO. R- 2867

A RESOLUTION OF THE KIRKLAND CITY COUNCIL AUTHORIZING THE CITY MANAGER TO SIGN ON BEHALF OF THE CITY OF KIRKLAND AN INTERLOCAL GOVERNMENTAL CONSORTIUM AGREEMENT FOR THE YEARS 1982 THROUGH 1984, ENTITLED "AGREEMENT FOR PLANNING THE DISTRIBUTION OF CERTAIN BLOCK GRANT FUNDS AND EXECUTION OF THE KING COUNTY BLOCK GRANT PROGRAM UNDER THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED".

WHEREAS, on December 19, 1977, in regular meeting, the Kirkland City Council, by Resolution No. R-2484, authorized participation by the City of Kirkland in a Housing and Community Development Act of 1974 Block Grant Fund Consortium with King County, and the execution of an Interlocal Governmental Agency Agreement for such joint participation, and

WHEREAS, King County, acting on behalf of the Consortium, has submitted to the City of Kirkland a new Interlocal Governmental Agreement for the three year period of 1982-1984, and

WHEREAS, the Kirkland City Council finds it to be in the best interest of the City of Kirkland and its residents to continue for said three year period as a participant in the Intergovernmental Consortium, now, therefore,

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1: The City Manager of the City of Kirkland is hereby authorized and directed to sign on behalf of the City an Interlocal Governmental Consortium Agreement for planning the distribution of certain block grant funds and execution under the Housing and Community Development Act of 1974, as amended, a copy of which said Agreement is attached to the original of this Resolution and by this reference incorporated herein.

Section 2: Pursuant to the Community Development Act of 1974, the Liaison officer for the City of Kirkland is hereby designated as Allen B. Locke, City Manager.

Section 3: The City Council of the City of Kirkland acknowledges that by entering into this Agreement, the City of Kirkland is committed to participate in the Block Grant Fund Consortium with King County and other participating jurisdictions during the entire course of the three year period commencing with the 1982 funding year, and ending with the 1984 funding year.



AGREEMENT FOR PLANNING THE DISTRIBUTION OF CERTAIN BLOCK GRANT FUNDS AND
EXECUTION OF THE KING COUNTY BLOCK GRANT PROGRAM UNDER THE HOUSING AND
COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED.

THIS AGREEMENT, made this _____ day of _____, 1981
by and between the governing body of King County and the undersigned
incorporated municipal jurisdiction within King County.

WITNESSETH:

WHEREAS, the Federal Government through adoption and administration of the Housing and Community Development Act of 1974, as amended, hereafter referred to as "the Act" will make funds available to the County of King, hereinafter referred to as the "County", for expenditure during the 1982-84 funding years; and

WHEREAS, the area encompassed by the County, exclusive of Seattle and Bellevue, has been designated by the U.S. Department of Housing and Urban Development, hereinafter referred to as "HUD", as an urban county; and

WHEREAS, the Act allows joint participation of units of general purpose Government within an urban county, and a distribution of some or all of these funds to such Governmental units; and

WHEREAS, the King County Council by Motion 1808 has established a Joint Policy Committee, hereinafter referred to as the "Committee", described in Section III of this agreement and a method for allocating funds described in Section II of this Agreement; and

WHEREAS, a majority of Block Grant funds available to our urban county are based on the population characteristic; and

WHEREAS, the Block Grant Regulations and King County Council Motion No. 1808 require the acceptance of both the Housing Assistance Plan and the Three Year Plan for Community Development by participating jurisdictions; and

WHEREAS, these plans must be realistic and a process must be established to settle any disagreements between the County and participating jurisdictions; and

1 WHEREAS, the County will undertake Block Grant funded activities in
2 participating incorporated jurisdictions as specified in the Three Year
3 Plan by granting funds to those jurisdictions for their execution, and by
4 undertaking such activities directly as are authorized by amendment to
5 this Agreement; and

6 WHEREAS, the County as the applicant is responsible to the Federal
7 Government for all activities undertaken with Block Grant funds; and

8 WHEREAS, the Housing Assistance and Three Year Plans must be revised
9 annually by the County and participating jurisdictions and submitted to
10 HUD as part of an annual application; and

11 WHEREAS, the purpose of this Cooperation Agreement, which is entered
12 into pursuant to and in accordance with the State Interlocal Cooperation
13 Act, RCW Chap. 39.34, is to form an urban county arrangement for planning
14 distribution of Community Development Block Grant funds and for executing
15 of projects in accordance with and under authority of the Housing and
16 Community Development Act of 1974, as amended.

17 NOW, THEREFORE, IT IS AGREED THAT:

18 I. GENERAL AGREEMENT

19 The County and each participating jurisdiction shall cooperate in
20 undertaking, or assisting in undertaking, essential community de-
21 velopment and housing assistance activities, specifically urban re-
22 newal and publicly assisted housing, as specified in the Community
23 Development Program and Housing Assistance Plan portions of the ap-
24 plication, for the program years covered by the Agreement.

26 II. DISTRIBUTION OF FUNDS

27 The Distribution within the County, exclusive of Seattle and Bellevue,
28 of Community Development Block Grant Entitlement Funds under
29 Title I of the Act shall be governed by the following provisions:

- 30 A. Five percent of the entitlement amount shall be reserved for
31 administration of the Block Grant Program by the County.
32 B. Ten percent of the monies remaining after II (A) shall be re-
33 served for allocation by the Joint Policy Committee with

2 concurrence of the County Council for innovative projects spon-
3 sored jointly by two or more member jurisdictions of the Conso-
4 rium. Projects shall be consistent with the Three Year Plan for
5 Community Development. These funds are part of the Needs Funds
6 described in II(E)(2) and II(F)(2) below.

- 7 C. The monies remaining after II (A) and II (B) above shall be
8 divided into two funds, the first designated for the County and
9 the second for the incorporated areas, according to the monies
10 brought to the fund based on population, poverty (counted
11 twice), and overcrowding: Provided, that consideration be given
12 in subsequent years to the advantage of pooling all monies into a
13 single fund.
14 D. In determining the portions of monies attributable to population
15 and need characteristics under II (E) and II (F) below, a minimum
16 of fifty percent (50%) of all monies remaining after II (A) shall
17 be assigned based on need.
18 E. The County funds shall be allocated as follows:
19 1. That portion of the monies brought to the fund based on
20 population shall be allocated to the unincorporated area,
21 and
22 2. That portion of the monies brought to the fund based on need
23 characteristics shall be allocated according to need without
24 regard to boundaries of participating jurisdictions.
25 F. The funds for the incorporated jurisdictions shall be allocated
26 as follows:
27 1. That portion of the monies brought to the fund based on a
28 jurisdiction's population shall be allocated back to the
29 jurisdiction, and
30 2. That portion of the monies brought to the fund based on need
31 characteristics shall be allocated according to need in the
32 incorporated areas of the participating jurisdictions.
33 G. Receipt of funds provided for in II (E) (1) and II (F) (1) (i.e.

1 population monies) is contingent upon review of projects by the
2 Committee, as provided in IV (B) (4).

3 H. Receipt of funds provided for in II (E) (2) and II (F) (2) (i.e.
4 needs monies) is contingent upon review and prioritizing of pro-
5 jects by the Committee and approval by the King County Council as
6 provided in IV (B) (5). Review and prioritization will be based
7 upon the Three Year Plan for Community Development.

8 I. If a project application is determined by a reviewing authority
9 to be ineligible under the Act or HUD Regulations, then the
10 monies which would have been assigned to that project will re-
11 main in the original fund to which they were allocated. These
12 monies will be made available for subsequent, valid project ap-
13 plications. If the monies assigned to a project exceed
14 actual cost, then the excess will be reallocated to the fund
15 origin for similar redistribution.

16 III. USE OF FUNDS: GENERAL PROVISIONS

- 17 A. The jurisdiction shall specify activities and projects which it
18 will undertake with these funds.
19 B. The jurisdiction shall conduct appropriate citizen participation
20 activities.
21 C. Approval of activities shall be secured in the annual program
22 and approval of projects must be secured in formal grant appli-
23 cations to the County.
24 D. General administrative costs incurred by each participating jur-
25 isdiction shall be paid for out of funds received based on popu-
26 lation or from local funds. Costs incurred in administering
27 projects shall be included in project costs.
28 E. That portion of the monies as provided for in II (F)(1) which
29 have not been allocated to a viable project within twelve (12)
30 months from the beginning of the program year shall be recap-
31 tured for redistribution to incorporated jurisdictions contin-
32 gent upon review of projects by the Committee as provided

IV(B)(6). Review and prioritization shall be based upon the
Three Year Plan for Community Development.

There shall be established a Joint Policy Committee.

A. Composition. The Committee shall be composed of the following
25

persons or their designees (who shall be specified in writing by

the elected member, and who shall be the same person consisten-
33
tly from meeting to meeting): The King County Executive; two King
County Councilpersons to be selected by the Council; and three
elected officials of participating incorporated jurisdictions
selected by the Suburban Mayors Association. Members of the Com-
mittee shall serve at the pleasure of their respective appoint-
ing authorities. The chairperson of the committee shall be
chosen from among the members of the committee by a majority vote
of the members for a term of one year: Provided, that a represen-
tative of a suburban city shall be designated as Chairperson at
least once in every two years.

B. Powers and Duties. The Committee shall be empowered to:

1. Review and recommend to the County Council all policy mat-
ters including allocation of funds.
2. Review Housing and Community Development objectives, plans,
programs, strategies, target areas, and funding levels for
recommendation to the King County Council and other partici-
pating jurisdictions.
3. Review and recommend program guidelines for project pro-
posals submitted by participating jurisdictions. These
guidelines shall define Community Development needs to be
addressed, target areas and populations to be assisted, and
priorities for funding.
4. Review and approve project proposals for funding under
II(E)(1) and II(F)(1) which are consistent with the King
County Housing and Community Development Objectives.

- 1 5. Review specific project proposals submitted by participating
- 2 jurisdictions for purposes of funding under II (E) (2) and
- 3 II (F)(2) and recommend to the jurisdictions and the County
- 4 Council their approval, disapproval, or alteration.
- 5 6. Review specific project proposals submitted by participating
- 6 jurisdictions for purposes of funding under III (E) and make
- 7 recommendations to the jurisdictions and County Council for
- 8 approval, disapproval, or modification.
- 9 7. Review staff suggestions for projects and programs to be
- 10 evaluated and recommend projects and programs for eval-
- 11 uation.
- 12 8. Be the arbitrator of plan and program disagreements between
- 13 the County and other participating jurisdictions.

14 V. DUTIES OF THE KING COUNTY STAFF

15 The King County Staff, hereinafter referred to as "the Staff", shall

16 fulfill the following duties:

- 17 A. Responsibilities to the Committee. The Staff shall:
- 18 1. Solicit and present to the Committee all applicable Federal
 - 19 and County policy guidelines, special conditions, and formal
 - 20 requirements related to the preparation of the Housing
 - 21 Assistance and the Three Year Plan for Community Development
 - 22 and related to administration of the programs under these
 - 23 plans.
 - 24 2. Prepare and present written materials required by HUD and
 - 25 the King County Council as components of the annual King
 - 26 County Housing Assistance and Community Development Plans to
 - 27 be prepared pursuant to this Agreement, including but not
 - 28 limited to: collection and analysis of data; identification
 - 29 of problems, needs and their locations; development of long
 - 30 and short term objectives; consideration of alternative
 - 31 strategies; and preparation of action year program and bud-
 - 32 gets, except that the initial activity descriptions and bu

gets proposed for inclusion in the annual program shall be prepared by agents of the parties to this Agreement.

3. Recommend target areas to be addressed, target populations to be assisted and policies for funding.
 4. Prepare and present to the Committee project evaluation reports for selected projects.

B. Responsibilities to Jurisdictions Which Are Parties to This Agreement. The Staff shall:

1. Solicit and present all applicable Federal and County policy guidelines, special conditions, and format requirement related to the preparation of the Housing Assistance Plan and the Three Year Plan for Community Development and related to program administration.
 2. Identify supplemental sources of funding to increase the participating jurisdiction's capability to conduct effective Community Development activities.
 3. Prepare and present written materials required by HUD and the King County Council as components of the annual King County Housing Assistance and the Three Year Plan for Community Development to be prepared pursuant to this Agreement, including but not limited to collection and analysis of data; identification of problems, needs and their location; development of long and short term objectives; consideration of alternative strategies; and preparation of action year programs and budgets. The initial activity descriptions and budgets proposed for inclusion in the annual plan shall be prepared by agents of the parties to this Agreement.
 4. Prepare and present project evaluation reports for selected projects.
 5. Present to the King County Council, as appropriate, the locally adopted annual program in general, and the included projects in particular.

6. Administer the Housing and Community Development Program.

VI. RESPONSIBILITIES AND POWERS OF JURISDICTIONS

The jurisdictions participating in this Agreement shall have the following responsibilities and powers:

- A. Subject to review by the Committee, each participating jurisdiction shall determine the use of funds allocated to it based on population in a manner consistent with the Three Year Plan for Community Development developed cooperatively by the member jurisdictions, adopted by the Committee and approved by the King County Council. Disposition of monies in case of project invalidity or in case of excess funds remaining after project completion, shall be in accordance with II (I) above.
 - B. The legislative authority of each participating jurisdiction shall approve or disapprove activities, areas and budgets submitted by its agents prior to approval by the Committee for inclusion in the annual program. Approval shall be given by motion or resolution.
 - C. Parties to this Agreement shall submit drafts of project proposals to the staff for review as to consistency with objectives and guidelines prior to the presentation of the proposals to the committee and to the King County Council, where appropriate. Each participating jurisdiction shall fulfill to the County's satisfaction all relevant requirements of Federal laws and regulations which apply to the County as applicant, including assurances and certifications.

VII. RESPONSIBILITIES AND POWERS OF THE COUNTY

The County shall have the following responsibilities and powers:

- A. The King County Council shall have authority and responsibility for all policy matters including plan and project approvals, after review and recommendation by the Committee.
 - B. The King County Executive, as administrator of this Housing and Community Development Program, shall have authority and responsibility

sibility for all administrative requirements for which the County is responsible to the Federal Government.

- C. The King County Executive shall have authority and responsibility for all fund control and disbursements.
 - D. Notwithstanding any other provision contained in this Agreement, the County as the applicant for Block Grant Funds has sole responsibility for and assumes all obligations as the applicant in the execution of this Community Development Program. Nothing contained in this Agreement shall be construed as an abdication of those responsibilities and obligations.

VIII. GENERAL TERMS

- A. This agreement shall extend through the 1982, 1983, 1984 program years.
 - B. During the period of this Agreement, no included unit of local government can be removed from the urban county for Community Development Block Grant purposes.
 - C. It is understood that by signing this Agreement the jurisdiction shall accept the Housing Assistance Plan and its "Realistic Annual Goals."
 - D. It is recognized that amendment of the provisions of this Agreement may become necessary, and such amendment shall take place when both parties have executed a written addendum to this Agreement.
 - E. Population figures as used herein shall refer to "The Official Population of Cities, Towns and Counties" as published annually by the State of Washington Office of Program Planning and Fiscal Management, subject to any later adjustments or corrections as to the population of any participant which is officially recognized by the Office of Program Planning and Fiscal Management.
 - F. Participating Jurisdictions shall be considered to be those jurisdictions which have signed this Agreement.
 - G. Jurisdictions undertaking activities and/or projects with Block Grant funds distributed under this Agreement retain full civil

and criminal liability as though these funds were locally generated.

- 10 H. The County retains environmental review responsibility for purposes of fulfilling requirements of the National Environmental Policy Act, under which the County may require the local incorporated jurisdiction or contractor to furnish data, information, and assistance for the County's review and assessment in determining whether the County must prepare an Environmental Impact Statement.
11 I. Jurisdictions retain responsibility in fulfilling the requirements of the State Environmental Policy Act under which the County has review responsibility only.
