A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND DECLARING ITS INTENT TO PARTICIPATE IN THE DEVELOPMENT OF A MULTI-JURISDICTIONAL PROJECT DESIGNED TO CONSERVE ELECTRICAL ENERGY CONSUMPTION IN NEW RESIDENTIAL CONSTRUCTION, AND TO FUND THE CONSERVATION PROJECT WITH A GRANT AWARD FROM THE UNITED STATES DEPARTMENT OF ENERGY, ADMINISTERED BY THE BONNEVILLE POWER ADMINISTRATION.

WHEREAS, the City of Kirkland is committed to the conservation of electrical energy within the community and is aware that energy affects significant aspects of local government services, development plans and activities; and

WHEREAS, the City of Kirkland recognizes that the consumption of electrical energy is a concern shared by other local jurisdictions; and

WHEREAS, the City recognizes the potential of conserving electrical energy through cost effective zoning, platting and building code changes that would reduce electrical consumption in new residential construction; and

WHEREAS, the Bonneville Power Administration has made funds available to local government entities for electric energy conservation and resource development planning under authority of the Bonneville Project Act of 1937 and the Federal Grant and Cooperative Agreement Act of 1977; and

WHEREAS, a joint application involving the Cities of Redmond, Issaquah, Bothell and Kirkland has been submitted to, and approved by, the Bonneville Power Administration for a residential electrical energy conservation project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

<u>Section 1.</u> The City Council of the City of Kirkland does hereby accept the grant award, No. DE-FG79-81BP33240, from the United States Department of Energy for the residential electrical energy conservation project.

<u>Section 2.</u> The project identified in Section 1. shall be a joint effort of the Cities of Redmond, Issaquah, Bothell and Kirkland, Washington whereby the four jurisdictions proceed cooperatively toward project completion and implementation.

Section 3. The City of Redmond represents the participating jurisdictions as the contract for the award identified in Section 1., the recipient and monitor of the grant funds.

<u>Section 4.</u> The Department of Community Development shall provide City of Kirkland staff liaison with the other municipalities referenced in Section 2 and shall keep both the other Departments and the City Council apprised as to the progress of this energy conservation study.

BE IT FURTHER RESOLVED that the results of the project study be utilized as a regional model for local governments to consider in the conservation of electrical energy.
